The introduction briefly contains problems, objectives, and state-of-the-art from the previous study. It should serve as proof of the originality and the novelty that needs to be published. Further, it should contain the gap analysis that describes the important or the unique things compared to the previous study. Then, the content of the introduction is written in paragraphs, not a su-bab of the introduction. Manuscript length is between 6,000 - 10,000 words, including abstract, footnotes, and bibliography.  METHOD (Gadugi, font size 11pt, justify, 1.15 line and paragraph space, justify, UPPERCASE)

It contains a description of the approach method, research specifications, types and techniques of data collection, and data analysis methods. If the research method uses a conceptual approach in analyzing the problems in the research, it is not allowed to include the research method chapter. The emphasis on the conceptual approach is only included in

References are arranged alphabetically in sequence "Chicago Manual of Style 17th edition (full note)" listed in Mendeley, by not grouping the reference sources that have been cited (precisely the results of interviews with respondents, not included in the bibliography). The

Regarding the change in the format template JUSTISI, there are several notes for the author:

- 1. Each manuscript is required to use Mendeley's standard citation application
- 2. The model used in the citation application is the Chicago Manual of Style 17th edition (full note)
- 3. Citation using footnote
- 4. Abstracts written in standard English include: contains research objectives, methodology, novelty, results, and conclusions (maximum 300 words).
- 5. Abstract should not contain any citations (should be stand-alone)
- 6. Manuscripts must follow the manuscript template provided by the Journal
- 7. Authors are prohibited from adding or changing author's name after the manuscript is accepted for publication
- 8. To ensure international collaboration and to reach a wider perspective, each manuscript should consist of a maximum of five authors and one or more authors should come from outside Indonesia affiliated institutions.
- 9. References used must be at least 25 latest journal articles (national or international) (last 5 years)
- 10. Every journal article cited in the References section must include a DOI or a direct link to the article
- 11. Conclusion, written briefly, precisely and concisely, should not be more than one paragraph and must answer the formulation of the problem discussed. This section is not allowed to contain quotes, and it is forbidden to rewrite/copy paste sentences or explanations that have been written in the contents section. The author must really write the conclusion with the new diction language.
- 12. The writing of laws/legal rules in Indonesia must include information regarding the State Gazette Number and include a link to the Law, while for international rules it is also obligatory to include a link to the regulation that can be traced directly
