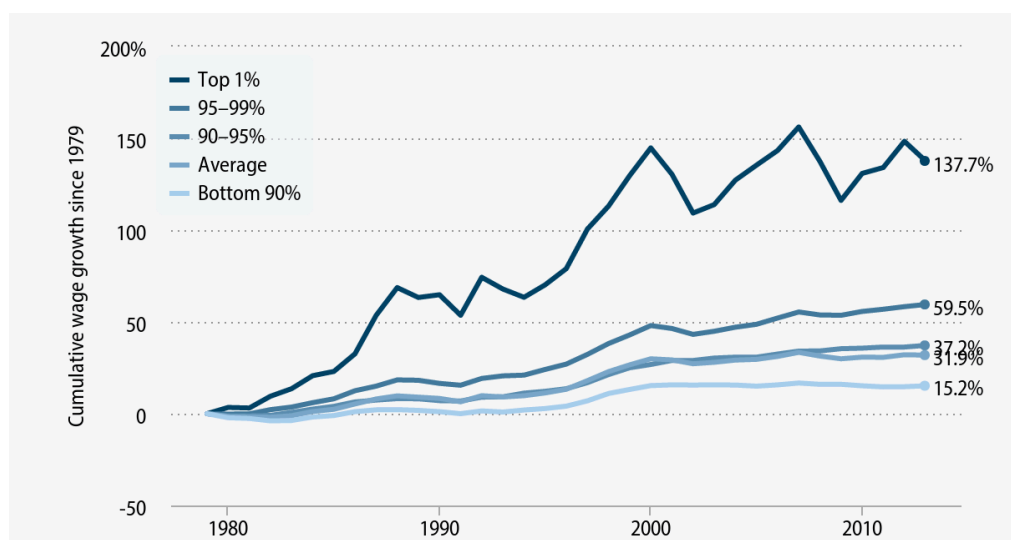

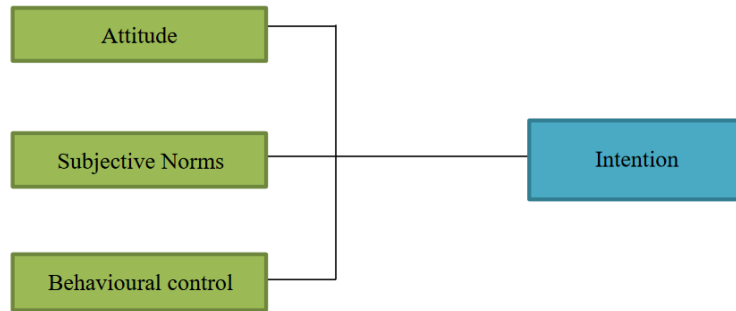
Cumulative Change in Real Annual Wages (Source, 2020)
