The introduction is written without sub-headings, and contains background, literature review and research objectives. The review uses literature or research results that are relevant to the reference provisions used no more than the last 10 years. The introduction is written using Open Sans font size 10. Spacing rules before 0 pt, After 0 pt, Line spacing Exactly, At 12 pt. (CLICK NORMAL ARTICLE)



REFERENCES (CLICK HEADING 1)

Writing a bibliography is required to use a reference management application (for example, Mendeley) with APA 7 (American Psychological Association version 7th) style. The bibliography is written using Open Sans font size 10. Spacing rules before 0 pt, After 0 pt, Line spacing Exactly, At 12 pt.

Conditions regarding references:

The references used are at least 30 references, and 80% are primary sources in the form of research journal articles from the last 10 years.

The more primary references that the paper has, the more qualified the paper will be. However, self-citation can reduce the paper score. Citations from previous EDAJ related articles are necessary.

Manuscripts are written by using standard citation application (Mendeley/ Endnote/ Zotero). Harvard style reference should be used. Ensure that the references are referred on the paper and arrange them alphabetically
