Ernest Lee Johnson is scheduled to be executed on October 5th, 2021, at 6 PM at the Eastern Reception and Diagnostic Correctional Center in Bonne Terre, Missouri. With this in mind, **we implore Governor Parson to call a Board of Inquiry to assess Ernest's intellectual disability claim and to grant Ernest Johnson clemency and commute his sentence to life.**
