The research findings should be measurable and should provide a detailed description of the instruments used, whether qualitative or quantitative. The author should elaborate the research findings. The findings and discussion relate to the literature and its practical implication. In this section, the author explains the research findings as an indicator of the research success. Furthermore, the research accomplishment can be observed in the proposed hypotheses and the novelty of the research.

E. CONCLUSION

The conclusion should clearly indicate weakness and strengths of the findings, as well as the potential for further research. It should be presented in a cohesive paragraph format rather than as a list of points.

F. REFERENCES

The references or bibliography consists of the publications from the last 5 years of research, except for the list of books or primary sources. The minimum number of references to be included is 15. Priority should be given to research papers from recent journals, conferences, and/or scientific magazines. Other references may include textbooks or research reports (including undergraduate theses, master's theses, and dissertations), but should not exceed 20% of the total number of references.

The references follows the American Psychological Association (7th ed.) format and is arranged alphabetically. The references included in the
