Terms and Conditions

- These specific Terms and Conditions for the <u>Klevio Airbnb New Host Campaign</u>
 ("Promotion Terms") are binding on all persons participating in the campaign organised,
 conducted and operated by Klevio Ltd. ("Klevio").
- For the Campaign Term, an Airbnb Host who completes a Qualified Listing, and hosts a
 Qualified Booking will receive a free Klevio One device as linked on the
 https://airbnb.vaz6fn.net/klevio, subject to a maximum of 5 free Klevio One per host
- 3. Campaign Term shall commence on the Effective Date of September 15th, 2019 and end on November 15th, 2019.
- 4. Designated Area means the Greater London area, located in the United Kingdom.
- 5. Airbnb Host means an individual who:
 - a. i. uses the affiliate tracking link from Klevio (as linked from the https://airbnb.vaz6fn.net/klevio) to create a new Qualified Listing;
 - b. ii. has successfully completed or successfully completes Airbnb's verification process; and
 - c. iii. does not have more than 5 active listings on Airbnb.
- 6. **Qualified Listing** means a space (whether a flat, house, a private room or a shared room) listed by an Airbnb Host on the Airbnb platform, that in Airbnb's sole determination meets all of the following criteria:
 - a. the listing is located in the Designated Area;
 - b. the listing is new and not previously activated or duplicated from another Airbnb listing;
 - c. the listing has a **description** in English with a **minimum of 100 characters**;
 - d. the listing is one of the first five Qualified Listings by that Airbnb Host;
 - e. the listing is not located in a hotel or similar property; and
 - f. the listing is listed during the Campaign Term (September 15th to November 15th, 2019).
- 7. **Qualified Booking** means the **first completed reservation and sta**y of a Qualified Listing that:
 - a. is not made by the Airbnb Host or any party affiliated with the Airbnb Host (including but not limited to friends, family members or household members);
 - b. has a total booking value (excluding Airbnb service fees, cleaning fees and taxes)
 of <u>at least £25</u>;
- 8. For eligibility, **purchase** of Klevio One device with a 24-month commitment to a subscription of £15/month ("Eligible Products") **must be made within promotion period**
- 9. The host must complete the creation of their listing within 30-days of clicking on the affiliate link to the Airbnb Site.
- 10. Klevio reserves the right to disqualify the buyer after announcement due to ineligibility of the buyer. Klevio is not required to provide any explanation for the rejection.
