# Syllabus for HLS-3900

## ETHICAL MANAGEMENT IN PUBLIC SAFETY

### **COURSE DESCRIPTION**

This course provides a general examination of the role of public safety leaders, including those in homeland security and emergency management, in shaping standards of ethical conduct at the individual, group, and organizational levels. Students will gain an understanding of the ethical challenges faced by public safety professionals in balancing core values, responsibilities, and compliance with the policies and regulations relevant to the institution they serve. This course also includes scenarios and simulations with reflective questions to help students think critically and constructively about real-life issues in public safety.

### **COURSE TOPICS**

- Ethical principles, values, and leadership
- Dimensions of organizational ethics
- Implication of ethics on the compliance context
- Methods for analyzing and solving ethical issues

After completing this course, students should be able to:

- **CO 1** Use the basic principles of ethics for public safety.
- **CO 2** Apply ethics to leadership approaches and practices.
- **CO 3** Connect the building blocks that form an ethical organization's culture.
- **CO 4** Associate ethical challenges with their position on a given ethical situation.
- **CO 5** Integrate ethical considerations into compliance activities.
- **CO 6** Promote ethical behaviors within an organization.

# Memo Assignment

You are required to complete one memo assignment.

# Presentation Assignment

You are required to complete **one** presentation assignment. The presentation assignment is on a variety of topics associated with the course modules.

# Dournal Assignments

You are required to complete **four** journal assignments. The journal assignments are on a variety of topics associated with the course modules.

# Final Project

The primary purpose of the final project is for you to imagine yourself facing an ethical dilemma and for you to determine a potential course of action.

Note the following:

- This is a group project; you will work as a member of a cooperative group to complete it. Your mentor will set up the groups before the class begins.
- The project is divided into four steps (milestones), which will be submitted progressively
  throughout the course. This will enable you to analyze ethical concepts as you move forward in
  the course and will ensure quality final submissions. The first milestone, selection of the
  dilemma your group will consider and identification of your organization, is due at the end
  of Week 1.
- Your group should work cooperatively to complete all milestones, but one group member will be designated to submit each milestone.

All activities will receive a numerical grade of 0–100. You will receive a score of 0 for any work not submitted. Your final grade in the course will be a letter grade. Letter grade equivalents for numerical grades are as follows:

To receive credit for the course, you must earn a letter grade of C or better (for an area of study course) or D or better (for a course not in your area of study), based on the weighted average of all assigned course work (e.g., exams, assignments, discussion postings).
