What do I actually draw?

I can draw any female character you want, whether it be your original character or fan-art for an existing one. Speaking of original characters, I can also help you design one (comprehensive references will be greatly appreciated in this case.)

Unfortunately, I still can't draw males all that well. Might consider very feminine dudes though!

NOTICE: I CURRENTLY DO NOT DO COMPLEX BACKGROUNDS. I CAN ONLY DO SIMPLE BG, SOLID OR GRADIENT COLOUR BGS ONLY. This is due to backgrounds being

my weak point. I do not feel right charging people for what I feel will be a sub-par product. Complex backgrounds may be an option once I become more confident in depicting them. Thank you for understanding.

Estimated time of completion/turnaround time

Commissions will take anywhere from 3 weeks to 7 weeks, depending on order quantity/complexity. I will update the progress of the commission at several stages; the line-art phase, base colours phase, and final rendering. I will also ask for the client's input if needed.

Do note that my commissions are on a first come, first served basis. If you happen to be on the tail end of a current commission batch, I will most likely start working on your order later. If you would like to know what 'position' your order is in, feel free to ask.

Finished pieces will be delivered via Google Drive by default. If needed, I can deliver via email as well.

Revisions

Revisions made during the sketch phase are free of charge (within reason, telling me to revise the entire sketch would be quite troublesome). 2x free revisions during the lineart and colour stage, after that is \$2–5 per revision depending on complexity of revision. Revisions made after the rendering phase are \$5–\$10 depending on complexity.

Payment

Payment will be done after the initial sketch has been agreed upon by both the client and myself. Payments can be made via PayPal (using US Dollars) for clients based outside of Indonesia. For Indonesians, bank transfer (BNI) or any QRIS e-wallet *EXCEPT DANA* (Gopay, OVO, Linkaja, etc.) is valid for payments as well.

For PayPal payments, there will also be a 10% charge to offset PayPal's currency conversion fees.

Add-ons

- **Variants:**
 - **Minor Variants:** Simple alterations such as having a piece of clothing on and off. Eg. Two versions of an illustration, one where the character has their jacket off, and another with their jacket on. – \$5
 - **Major Variants:** Full, alternate versions of the illustration. Things such as having an entirely different outfit, hairstyle, or other alterations of a similar nature. – \$10 – \$15
- **Tactical Gear:**
 - An extra fee will be charged for the inclusion of firearms and combat gear. Fees are as such:
 - Firearms – \$15/main unit, holstered sidearms will not be counted, but if the main focus is the sidearm, it will be counted.
 - Attachments – \$2/item (optics, scopes, lasers, lights, etc.)
 - Tactical/Combat Gear – \$5/item (Plate Carriers, Chest Rigs, Helmets (tactical/ballistic and flight), etc. Extends to historical gear as well (WW1/2, Vietnam, etc.)
 - Camouflage Patterns – \$4
 - Please provide sufficient references.
- **Complex Character Designs:**
 - This \$10 add-on charge applies to most v-tubers and gacha game characters (eg. Arknights, NIKKE, Hoyoverse games, etc.). Characters with simpler designs will not be charged. Consult with me first and we can discuss if this add-on is valid for your request. (example: characters with complex details like Ho'olheyak from Arknights will be charged, characters with simpler outfits like Ako from Blue Archive will not be charged)
 - If you wish to depict said characters in an alternative, less complex outfit, this add-on will not be charged.
 - This add-on also applies to characters (OCs or any pre-existing characters) with complex/mechanical designs such as suits of armour, cyborgs, accessory-heavy designs, etc. Same price applies.
- **NSFW:**
 - NSFW pieces will be charged a flat \$12. The 'NSFW tax' applies to any pieces with full R-18 action or shown genitalia. (Risque/pin-up pieces that do not show genitalia, e.g. bare chests, will not be charged the NSFW tax.)

- **AIRCRAFT/VEHICLES:**
 - I still heavily rely on 3D models to aid the process. I may decline an order for aircraft/vehicles if I cannot source a 3D model of the aircraft/vehicle in question.
 - **FULL-RENDER – \$35/UNIT**
 - **BASE COLOURS/LINEART – \$20/UNIT**
 - **“Custom” liveries for aircraft will be \$3. Real-life liveries for said aircraft will not be charged.**

- I reserve the right to refuse service for any individual.
- Upon completion, I reserve the right to post the piece on my socials as a part of my portfolio. However, if you prefer to remain anonymous, let me know beforehand and I will not tag you when I post.
- Cancellations made by the *client* after payment has been made **WILL NOT BE REFUNDED.**
- Cancellations made by *myself* after payment has been made **WILL BE REFUNDED.**
- If the order is cancelled at the sketch stage/before payment, **YOU ARE NOT PERMITTED TO USE THE SKETCH ANYWHERE ELSE WITHOUT CONSULTING ME FIRST.**
- **NFT and AI usage is *STRICTLY PROHIBITED*.**
- I will refuse any orders with extreme fetishes such as, but not limited to, inflation, vore, and guro/gore.
- I will refuse any orders with sexualised/inappropriate *loli/shota* content.
- I will refuse any orders endorsing any political figures/parties/movements.
- I will refuse any orders containing hate messages. In other words, no discriminatory, racist, sexist, homophobic and/or transphobic messages.
