Section 1

Preamble

This document serves as the official contract between **XeXileIVX's SCP Foundation**, and **lofedev's Global Occult Coalition**. On behalf of the Department of External Affairs, we formally introduce this Foundation to our roster of affiliations; and this affiliation is focused on the promotion of both Foundations mutually between both groups.

Both parties involved with this document are to upkeep all documentation, and information related to the Foundation in the highest regard possible, thus the Foundation is responsible for actions made behalf of itself and by representatives that are assigned to this relation, and vice versa.

Section 2

Terms

The following are regulations that both parties have officially approved that they will follow on behalf of their party, furthermore the signatures ensure that these terms are unkept, and ensure that violations of this term may be handled in the most diplomatic of manners.

1. Notice of contract termination shall be given at least 72 hours in advance before taking effect. This may be initiated by either party in the event that any of the sanctioned events were to occur: *Multiple Term Violations; Representative Misconduct; Executive Order.*
 - a. **Multiple Term Violations:** In the event that either side continues to violate the contract it may be terminated.
 - b. **Representatives Misconduct:** This does not apply to interim representatives, or delegations, this applies specific to and only to leadership members.
 - c. **Executive Orders:** These are orders committed by The Administrator that initiate things on behalf of themselves as an official direction towards the department, these are changes authorised by The Administrator, and may only be overruled by council motion.
2. Neither party shall engage in defamation, slander, or any actions intended to undermine or sabotage the other. This includes propaganda, public discussion, public speech, representatives of either group may not engage in hostile behaviours between either party acknowledging that it is with slanderous, or hostile intent.
 - a. Propaganda related that are negative, hateful, or defamatory in nature, with the intent to cause damage, or harm towards the Foundation's reputation is included in this.
 - b. Public Discussion includes discourse amongst either group that is considered a "Primary Public General"; which applies to in Aphelion: **#aphelion**, and **#altgeneral**, but is not limited to only those channels.
3. Mutual respect shall be maintained among all members of both parties to this agreement. This condition applies to every individual affiliated with either party.



- a. This means that representatives may not join the embassy if they are *blacklisted*, or *permanently excommunicated* from the Foundation as it would create tension within relations with regards to decision making and handling important information.
- b. Respect also includes utilising conversation to be constructive instead of defamatory, and destructive towards either party, conflict may occur however it may not negatively impact the future of the embassy.
4. Members from one party may join the other and maintain membership on both without restriction or prejudice.
5. The conduct of intelligence or espionage operations by or between either party is strictly prohibited. This includes the implementation of agents, or otherwise infiltration into either group by any means.
 - a. Either party may hold an intelligence-based department, however is to refrain from conducting such operations in a manner related to our foundation.
 - b. Members of both parties are strictly prohibited from joining or participating in the operations of any intelligence apparatus.
 - c. The discovery of any intelligence or espionage activity involving either party shall result in the immediate termination of this agreement.
6. Neither party shall knowingly harbour or assist any individual recognised by either party as a threat to the safety and security of the community. This includes individuals that may pose a threat towards the integrity of enforcement, or towards the integrity of foreign affairs. Individuals may not induct persons of such nature.
 - a. This provision includes, but is not limited to, individuals found to be involved in activities such as paedophilia, doxxing, distributed denial-of-service (DDOS) attacks, or any similarly harmful conduct that is in direct violation of either Roblox or Discord Terms of Service, or in direct behaviour that contradicts any given regulations provided by any regulatory authority.
7. Both parties reserve the right to issue a formal request for the removal of any individual deemed a threat to the community, this may be done to an extent, individuals that are ranked as *director* and *above* within either party requires proper evidence and investigative materials.
 - a. Operations may be conducted in an investigative-based manner in the event that it is sanctioned and it is handled in a proper manner, individuals

- may not infiltrate the ranks to find information, but can interview, or conduct hearings to gather such information.
- b. Investigations are to be shown to the corresponding embassy related to this Foundation, moreover this contract does not prevent the removal of individuals, however core individuals such as O5-X and The Administrator may not be removed.
8. The use of any intellectual property or assets belonging to either party—including but not limited to logos, models, scripts, and other proprietary materials—by the other party is strictly forbidden without explicit prior consent.
- a. This includes any content shared between embassies, that may be considered confidential, or in other words explicitly private to the Foundation’s operations, moreover the foundation may implement external access programmes and utilise the “main” logo in this manner.
9. The signatory party shall be granted three representative positions to represent its interests within the Department of External Affairs, each representative is to sign as they come, and as this contract is ratified, any changes are to be notified and re-signed upon by all members of the embassy.
- a. Changes can be made by both parties, however each new term requires the re-authorisation of a signature, and the date *must* be recorded officially, and within the internal records of the Department of External Affairs.
 - b. Should any member of either party be found in violation of the terms or regulations outlined in this agreement, it is expected that appropriate disciplinary action will be taken by the respective party.
