Zone 5 Lt Williams

- Noise complaint about a street performer near Pemberton Place to NPU-M Public Safety. **Didn't bring information one. Reminder LT Williams we asked for results last month.**
- Burglary at White Oak Kitchen (March 26)- pass on to investigators. **Ask Zone 5 to look at the video because the person's face was visible and they may be someone they know.**
- 254 Auburn Ave - After Hours Spot - Aggravated Assault (April 9) - **illegal after hours spot. A person was assaulted and a gun pointed at them.**
- If the sidewalk is blocked with scooters is this an APD call? **Call 911**
- 255 Ted Turner **April 11th this location was shut down for illegal operation with the Fire Captain.**

Zone 6

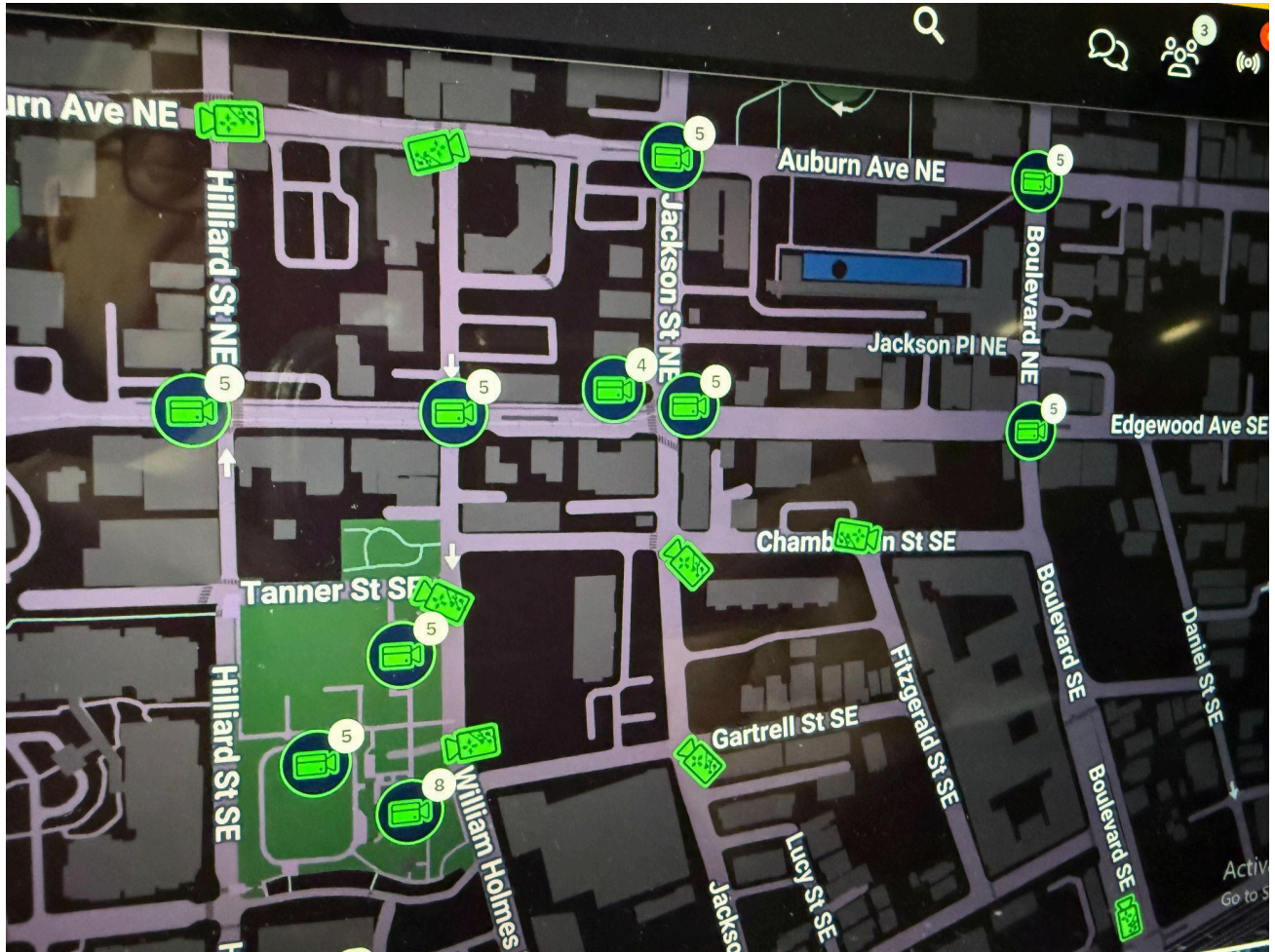
- 552 Parkway Dr. NE, Atlanta, 30308, with the adjoining parking lot at 415 Linden Avenue. Suspicious activity occurring in the parking lot during late evening and nighttime hours. Security footage from neighborhood Ring cameras shows repeated inappropriate activity, including possible prostitution or sexual conduct. **Will have her team focus on this issue.**
- Shooting in an illegal parking lot on Edgewood Ave. **This is now in the Mayor Office to discuss what should happen next.**
- Noise compliant at Iconz Sport Bar - again (does not have Entertainment on Application for alcohol and should not be blasting music). **Working with License and Permits on this location.**

Neighbor Comments

- **Unhoused are being more aggressive walking in private businesses that are appointment only.**

- Our business across Boulevard had to close early on 404 Day due to a street takeover and blocked traffic that created unsafe conditions. Officers were present but did not intervene when the street was blocked. Events like this need better planning and enforcement to protect nearby businesses, employees, and the comm
