- **Chapter Meeting Attendance/Financial Reports** submit to National within 30 days of every meeting (Sec/Treasurer)

- **Chapter Meeting Notices/Webpage Postings** – submit to National 4 weeks prior to the event date (access via website) (Communications Chair and Presidents have access)
- **Chapter Meeting Notices** – emailed from National to all Chapter members 2 weeks before events when requested (Communications Chair)

 - o **Affiliated School** – send National an email if you would like to recruit a school to join; must be submitted within 30 days of their join date. ***No bonus funding accepted after December 15.***
