Meeting started at 7:09p

- 1) Welcome
- 2) Introductions
- 3) Review and approved April 2022 meeting minutes with a change to reflect JV swim record: motion to approve made by Maureen Currie, Alexis Hoekstra seconded; motion approved unanimously
- 4) Treasurer's report:
 - a. Highlights: Net income decreased about \$4,000 to overall NI approx. \$9,000 compared to target of <\$18,204.75>. Still have income to spend
 - b. Income sources: Corporate matching (126% of budget) Snack shack (84% of budget), merchandise sales (100% of budget) and a small Script amount.
 - c. Expenses came from non-sports (46% of budget) and sports items (83% of budget), general admin (30% of budget), snack shack supplies (a little above 100%) and tax prep fees (at budget).
 - d. Re: 501c3 status. Maureen has filed amendment for change from 501.c.4 and now waiting for update.
 - e. A motion was made to move \$200 from trainer to strength and conditioning coach. Angie Lu made the motion and Kris Suzuki seconded. Motion passed unanimously.
 - f. A motion was made by Maureen Currie to move \$7,800 to sports specific from trainer and seconded by Angie Lu. Motion passed unanimously.
 - g. New funding requests:
 1. Girls soccer: up to \$6,500 for two sets of 25 uniforms; CA Sports Design is going to be a team dealer for uniforms and will be producing the uniforms. To be invoiced and shipped by June 30. Alexis made a motion to provide up to \$6,500 for the uniforms and it was seconded by Angie Lu. The motion passed unanimously
 2. Strength and conditioning coach: asking for an additional \$200 to get to the expected \$4,800 stipend for the Spring session as per Kyle Padia. A motion was made by Elizabeth Sorace to provide \$200 to the strength and conditioning coach and was seconded by Jen Lipscomb; motion passed unanimously.
 3. Baseball is requesting up to \$1,500 for new JV uniforms which includes already deducted \$1000 from fundraising efforts. A motion was made by Jen Lipscomb to provide \$1,500 for baseball uniforms and Maureen Currie seconded it. The motion approved unanimously
 - h. A request has been made from Maureen to have receipts in by June 17th if possible.

- 5) AD Update
 - a. Golf had two CCS qualifiers; we will be hosting the badminton championships; other sports are winding down after very strong seasons.
 - b. College signing day will be Friday, May 6th, at lunch in the quad.
- 6) Coach or Sports Rep Update
 - a. Swim presented by Coach Kyle – BVALs just completed with lots of good swimming. Leigh girls won meet and boys came in 3rd. 15 swimmers/1 diver will be competing at CCS.
- 7) Committee Reports
 - a. Donation Drive/Fundraising: Both Rachel and Josita will be staying on in positions for next year. Karoke/CornHole Tournament with coaches and parents. Looking at 9/24 at Belwood Cabana and food trucks as a possibility and also still working on the ROI of a full event.
 - b. Merchandise: Sales continuing of various items and middle school parents are buying for their graduates.
 - c. Communications: Send pictures please!
 - d. Senior Recognition: Jen helped with getting the last team done and now it is to the printer. For sure \$1,500 has been raised as of this moment and next week Alexis will be making the remaining calls for fundraising.
 - e. Snack Shack: 4 football dates for next year and baseball snack shack was robbed of all the inventory of snacks/drinks/candy. Drew has gotten a new handle and lock installed
 - f. Dining Night Out: Pizza my Heart on Camden on May 11, 2022 will be the next DNO. It was a strong fundraiser last time.
- 8) New business will be tabled until next time
 - a. Leigh Stampede – May 21, 2022. Setting up a Sports booster table;
 - b. Officer slate for 2022-23. Maureen and Alexis are staying in positions past term limits so the community needs to approve their staying over term or come up with alternative candidates. Jen will work with Angie to post it on the website for approval/new candidates with final vote on June 6th.
