Net income is for the year is \$38,500.

Over 65% of income is coming from donations, due to large donations of \$45,000.

The thrift store has made \$21.500 YTD.

Most expenses going towards the cats.

We always need to ask about backup plans.

Adoption fees and medical costs

Adoptions are lower because of free adoptions through other shelters

We haven't taken in as many kittens, but we have had sick kittens, fewer fosters, and free adoptions event

Many applications are suboptimal.

We need to put kittens on petfinder and facebook/insta/other socials.

To compound the problem, we are getting many returns on cats

One thing we can do is get different kitten fosters each week bring kittens to the shelter on Saturday. Should have at least second set of vaccinations.

Going to see if we can have a kitten day at PetWants in Floyds Knobs.

There's an end of October adoption day at Petsmart. We should set up there.

Some fosters don't have time to socialize their kittens which creates a problem when trying to adopt them.

We are afraid Petsmart is going to kick us out.

We cannot raise prices since that would decrease our adoptions even less.

Open shelter Friday evenings, even one evening a month.

We are gonna start checking the medical supplies. There's an inventory sign out sheet and a medical tracker.

 Support from Dr. Evinger, retired vet – license expires at the end of October. She has offered to be the vet for the shelter. Everyone agrees that she should be the vet for the shelter.
