

EXECUTIVE DECISIONS

I. Definitions and Organization

Identification: Executive decisions will be listed with a number indicating the presidency term, followed by a hyphen, and another number that indicates the decision identification number (example: ED 1-1, is the first executive decision that took place during the first presidential term).

Decision Depository: Executive decisions will be listed in this document in three sections. The first section shall contain definitions. The second section shall act as a table of contents with the (1) executive decision number and (2) summary/title of the decision. The third sections shall hold the full text of the decision including the (1) identification number (2) full title (3) full text of the decision, and (4) links to the reddit discussion and related discussion.

ED 1-2 Operating Procedure for Property

I. General:

The Secretary of Transportation and Zoning (S-TAZ) is appointed by the President.

A Deputy of Transportation and Zoning (D-TAZ) may be appointed by the President, or by the S-TAZ and approved by the President.

II. Operating Procedures That Apply to All Secretaries and Deputies.

1. All plots must be squared or rectangular.
2. Every resident's first plot of land is free.
3. If a resident or citizen wants a second plot they will have to purchase it *see SEC. V below for pricing*.
4. When a new resident is given a plot of land, all four corners must be marked with brackets, and torches.
5. It is the job of the person who assigns the land to help the new resident understand their property bounds and the consequence for building outside of the bounds (destruction for roads and alleyways).
6. A deputy or secretary may not give him/herself a plot of land.
7. A deputy or secretary may not give a second or subsequent plot of land away for any benefit for him/herself.
8. All condemnations that take place due to escheat must be approved by the President.
9. Condemned property deemed to escheat may not be distributed without the permission of the President.
10. Property that has escheated to the state may be sold *see SEC. V. for pricing*
11. No property shall be distributed to new residents or citizen for free or sale if any part of the property is located in the eastern ocean of Columbia. ED 1-3

II. Specific Operating Procedures for S-TAZ

1. May give out unlimited small sized plots (*see below for detail*).
2. May give out unlimited medium sized plots (*see below for detail*).
3. Must get permission from the President before giving out large sized plots (*see below for detail*).
4. If the S-TAZ wishes to acquire a plot of land for him/herself or a friend/business associate where there may be a conflict of interest, they must get permission from the President.

III. Specific Operating Procedures for D-TAZ

1. May give out unlimited small sized plots (*see below for detail*),

2. Must get permission from the S-TAZ before giving out medium sized plots (*see below for detail*),
3. May not give out large sized plots (*see below for detail*),
4. If a deputy wishes to acquire a plot of land for him/herself or a friend/business associate where there may be a conflict of interest, they must get permission from the S-TAZ.

IV. Definition of Plot Sizes:

Small Plot:

Any plot less than 25x25, or have a surface area less than 625 blocks total.

Medium Plot:

Any property greater than 25x25 but less than 50x50, or have a surface area greater than 625 blocks but less than 2500 blocks total.

Large Plot:

Any property greater than 50X50, or have a surface area greater than 2500 blocks total.

V. Pricing of New Plot to Non-resident, Additional Plot to Resident, or Escheated Property:

A second plot may be purchased by a resident or citizen for the price listed in this section.

Small Plot: 25 Iron

Medium Plot: 50 Iron

Large Plot: Must be negotiated

Escheated Plot: Fair market value at auction, or highest contemporaneous offer.
