

OFFICIAL CONTEST RULES

*By submitting an entry all contestants automatically agree and will abide by the rules outlined below *

I. ELIGIBILITY & ENTRY: NO PURCHASE IS NECESSARY TO ENTER: the contest is open to legal residents of anyone (1) of the forty-eight (48) contiguous continental the United States or the District of Columbia (excluding Alaska, Hawaii, Puerto Rico, all U.S. territories and possessions and overseas U.S. military installations) who are twenty-one (21) years old and over. Employees and families of Oak Place HSV LLC., its affiliates, and participating sponsors and their affiliates are not eligible to win.
