 - o Dates will be planned well in advance so that important events can be planned for or dates adjusted as needed.
 - o Ann asks that we review the calendar and note and be aware of important dates.
 - o Discussed the formation of Congregational Conversations Task Force to create congregational conversations and ensure that they happen.
 - o Caroline, Kaiya and Ann would like to be on this task force.
 - o **Motion #3:** Ann moves that the Board of Trustees approved the formation of the Congregational Conversations Task Force and its mandate.

- o Motion passes unanimously.
- Committee on Shared Ministry
 - o **Motion #4:** Ann moves that the Board of Trustees approve the formation of the Committee on Shared Ministry and its charter.
 - o Frequently Asked Questions & Answers will be put together on shared ministry.
 - o mandi has several recommendations for members of this task force.
 - o Additional recommendations were discussed. Any additional recommendations for members should be shared with mandi and the rest of the board.
 - o Discussion was had about where this committee fits into the organization of the church and why the members must be selected in agreement between the board and the minister.
