How is testing day different than a "normal" day at TCGIS?

The day(s) of MCA testing, everything *except for the two testing periods* is the same. There are a morning/afternoon circles, recess/lunch, and opportunities for kids to move, relax, and socialize. Each class is scheduled for two 50 minute consecutive periods - either morning (am) - after morning circle or afternoon (pm) after recess/lunch or even closer to the end of the day depending on teacher recomendation. Throughout the testing time the kids are notified about the scheduled longer breaks in advance and are provided with student/teacher driven comfort breaks interspursed.
