1. **GENERAL.** The Aquaphor #AquaphorMyBSF Giveaway (the “Sweepstakes”) will begin on **WED 10/29/25 at 1:00 PM EST** and end on **WED 11/05/25 at 5:00 PM EST** (the “Promotion Period”). Before entering the Sweepstakes, each entrant must review and be bound by the Sweepstakes Terms and Conditions as set out below.
