The method of writing articles is required to meet the provisions for the publication of scientific articles, by presenting various reviews with a systematic that describes the author's scholarship and in accordance with other scientific rules. The conclusions made by the author are presented clearly and easily understood by those who have the same educational discipline background as the author.

Keywords: keywords consist of 3-6 words from terms that are specifically discussed in the article.

1 Introduction

In the title section, the font size is made 14 pt, printed in bold, with Times New Roman font, while for the sub-title, the font size is made 12 pt, printed in bold, with Times New Roman font. The title column is separated by two spaces with the body of the article. Use a font size of 11 pt, with Times New Roman font for the body of the article with a delimiter between lines using one space, between paragraphs made two spaces, and three spaces made to separate the body of the article from the title below. To submit an article, the author is required to follow the writing with this template, and then follow the instructions in the second section.

2 Writing Style and Format

2.1 Mathematical Formula

Mathematical formulas are given numbers marked starting with (1) which are placed right aligned, the writing of mathematical equations is placed 1.5 cm from the left side of the article

body. To create mathematical equations, use the agreed general symbols. As an example, the following shows how to write and place mathematical equations:

$$x^2 + y^2 = z^2 \quad \dots(1)$$

2.2 Figures and Tables

All images are placed in the center of the article body, and numbered sequentially. The image title explanation is made with sentence case, placed in the center of the article body.

5 Citation from Bibliography (Literature Citation)

References that are citations from the literature are marked with the last name/family of the author. For statements with references made at the beginning of the sentence, they are made in the following manner:

Brown (2014) in his research stated that... with the resulting equation:

$$\frac{x^2}{4} + \frac{y^2}{9} = r^2 \quad \dots(2)$$

As a note, if an article cited is written by more than three authors, then at the initial stage all authors are made complete, for example: "Research is a scientific way to find/prove the truth, or what is believed to be the truth (Brown, Williams, & Rogers, 2014)". The next citation is sufficient with the name of the first author followed by et al., for example: "Furthermore, Brown et al. (2014) stated that to evaluate the objectivity of the research paradigm, it is necessary to verify the literature used".

6 Article Contents

The contents of the article consist of:

- (1) Title
- (2) Authors and their institutions
- (3) Abstract
- (4) Article body (Introduction, Literature Review, Research Method, Research Results and Discussion, Conclusions and Suggestions)
- (5) Acknowledgment/thank you
- (6) Nomenclature
- (7) Reference

The introduction must contain an explanation of the background of the research that contains the problem phenomenon clearly along with the opinions of previous researchers regarding the research conducted. The literature review needs to contain a complete explanation of the theory used, the relationship between research variables that are strengthened by a review of relevant previous research. The research method must contain the methods used in the research such as the research method used, data analysis methods, and other things related to the research method. The research results and discussion need to contain

findings from the research conducted which are discussed systematically and completely in accordance with the initial formulation of the research supported by a study of the established theory. Conclusions and suggestions contain conclusions from the results of the research conducted as well as research suggestions for objects, other researchers and other parties.
