1. Our oregongreenparty.com website expires on March 31, 2025 and must be renewed or cancelled. The cost for another year is about \$221.00.

The website is seeing very little traffic, but members think it should remain open or be moved to another domain. Chuck offered to donate \$100.00 to keep the site open, but Dan strongly objected to spending the money.

Dan recommended moving it to new domain to save money with a new introductory price. Dan volunteered to find a new domain and move the articles and information on the existing website to the new website.

Moving it requires changing the name. This could entail a minor change from .com to .org or a major name change. OregonGreens was the name that was agreed on.

2. Defend The Guard SB 667 is in the process of a language change to remove the Governor may not order out for service to language similar to that of the Arizona Legislation which is:

"A. NOTWITHSTANDING ANY OTHER LAW, THE NATIONAL GUARD OF ARIZONA MAY NOT BE RELEASED FROM THIS STATE INTO ACTIVE DUTY COMBAT UNLESS THE UNITED STATES CONGRESS HAS PASSED AN OFFICIAL DECLARATION OF WAR OR HAS TAKEN AN OFFICIAL ACTION PURSUANT TO ARTICLE I, SECTION 8, CLAUSE 15, CONSTITUTION OF THE UNITED STATES, TO EXPLICITLY CALL FORTH THE NATIONAL

GUARD OF ARIZONA FOR THE ENUMERATED PURPOSES OF EXECUTING THE LAWS OF THE UNION, REPELLING AN INVASION OR SUPPRESSING AN INSURRECTION. THE GOVERNOR SHALL TAKE ALL ACTIONS NECESSARY TO ..."

Examples of such conduct include excluding Zionists from an open event, calling for the death of Zionists, applying a 'no Zionist' litmus test for participation in any Harvard activity, using or disseminating tropes, stereotypes, and conspiracies about Zionists (e.g., 'Zionists control the media'), or demanding a person who is or is perceived to be Jewish or Israeli to state a position on Israel or Zionism to harass or discriminate."
