

Terms and Conditions

Spring Fair x Faire Voices Of Retail Survey 2026 Free Prize Draw Offer

1. Eligibility

2. How to Enter

The survey form will request information about your business and job role to help tailor your experience should you win. Only one entry per person is permitted. Entries made using multiple email addresses or identities will be disqualified.

3. Opening and Closing Dates

The prize draw opens at **9:00 am on Sunday, 1st February 2026**. The closing time and date of the prize draw is 11:59 pm on **Sunday, 1st March 2026**. Entries received after this time will not be accepted.

If for any reason a technical interruption or fault occurs during the submission of the entry form, the Promoters do not take any responsibility.

5. Draw Date and Prizes

Five (5) winners will be selected and announced on **Friday, 20 March 2026**. Winners will be selected at random.
