

Section 1: CRC Structure Overview

1. The CRC Will consist of 5 members with equal voting power and rights.
 - a. One member of the CRC will serve as Chair. A second will serve as Vice Chair. (See Chair Section)
2. At the conclusion of every season, 2 new members of the CRC will be elected. Up to 2 members of the CRC will retire to make room for these two new members (see Retirement Section)
3. The 2 new members of the CRC will be elected. One will be elected by a combined vote of the previous season's CRC and Captains. The second will be elected by the community (See Election Section)

Section 2: Chair and Vice Chair

1. Duties of the Chair
 - a. It is the Chair's duty to lead the CRC and to represent it as a single leader. The Chair is tasked to maintain the general well being of the league.
 - i. It is the Chair's responsibility to organize the CRC and its responsibilities.
 - ii. The Chair is responsible for interpreting CRC rules for game time decisions (such as eligibility requirements)
 - iii. The Chair is responsible for ensuring the CRC maintains connections with other leagues (MLTP) and the community at large
 - iv. If the Chair is unable to serve in their role (either due to unavailability or recusal) the Vice Chair would fill their Role.
2. Chair Selection
 - a. At the conclusion of the season, the 5 members of the existing CRC will select among them who will serve as Chair for the upcoming season.
 - b. Any CRC member can serve as chair for the following season. There is no term limit on consecutive seasons a Chair can serve in that role.
3. Vice Chair
 - a. After elections, the 4 non-Chair CRC members will select from among them one to serve as Vice Chair.
 - i. In the event of a tie, the Chair will cast the tie breaking vote
 - b. The Vice Chair has no extra role except in the absence of the Chair, at which point they will take on the regular duties of the Chair.

Section 3 Retirement

1. At the conclusion of a season (and after selecting a new Chair), up to 2 members of the CRC will retire in order to create exactly 2 open spots on the CRC (i.e. 3 members will remain on the CRC).

- a. *The newly selected Chair for the upcoming season is exempt from retirement*
- 2. Members will retire based on the following order until 2 seats are open.
 - a. Outgoing Chair from the previous Season
 - b. Longest Tenured CRC member
 - i. If 2 members are tied for longest tenure (elected the same season), the one whose election format (Captains and CRC (CC) or Community) is opposite the new Chairs.
 - 1. *Note: This is to keep a balance between the number of active CRC members elected by the community and those elected by Captains/CRC*
- 3. Retiring members of the CRC are eligible to run for reelection at the end of their term.

Section 4: Elections

- 1. At the conclusion of the season, an election will be held to fill the 2 vacancies on the CRC.
- 2. The election will be conducted by the CRC and overseen by the League Manager.
- 3. The CRC will call for election applications and allow reasonable time for people to submit them.
 - a. Applicants will be made public to allow reasonable time for interpretation prior to the election.
 - b. The same list of applicants will be used for both seats.
- 4. The first seat will be filled by a combined vote of the previous season's CRC and Captains.
 - a. The election will be a linear scored borda count, $n=1$ (last place is 1 point, 2nd to last is 2, etc.) with full ranked ballots (must rank all candidates).
 - b. The candidate with the highest Borda Count fills the seat
- 5. The second seat will be filled by a vote of the NLTP Community from the remaining applicants.
 - a. The NLTP Community is defined as
 - i. Players and Non-Playing Captains from the previous 3 seasons of NLTP
 - ii. Players signed up for the current season's draft at the time of ballot posting who's last season of play was in NLTP
 - b. The Vote will use an Instant Runoff Vote (IRV) with partial ranked ballots (voters rank as many candidates as they would like)
 - c. The winner of the IRV will fill the 2nd seat

Section 5: Vacancies

1. In the event of an unexpected vacancy on the CRC midseason (due to a retirement, VONC, or other issue), the remaining CRC members will appoint a replacement for the remainder of the Season.
 - a. At the conclusion of the season, the appointed member is retired, and that seat becomes one of the two open seats in the election.
 - b. The appointed member does not have any term restrictions and can run for election to the CRC immediately.
2. In the event of an unexpected retirement at the end of a season (i.e. a newer member elects to retire early), that seat becomes one of the two vacancies for election.
3. In the event that 3 or more vacancies are present on the CRC, the remaining CRC members or a designated Transition Committee will conduct a special election to establish the new CRC.
