Old Business

Work Bench and Parts Storage – The cabinet and trays were delivered to Ryan, and he will take it to the shed. Dick talked to Welte's about the work bench. Ray Dentlinger moved to amend the previous motion of purchasing a work bench with dimensions of 96" by 34" to purchase a work bench with a 30" depth (the standard bench depth) at \$770. Jack Gangwish seconded the motion. The motion passed.

State Shoot

- Trophies Dan has not been able to get in contact with Char to see what she has decided.
- White Flyer is in for the same money as last year with event sponsorship and ad.
- Ads There have been complaints that John and Ryan have fielded about the price of ads. Jack Gangwish moved to amend the motion from October 14th meeting with ad prices to now read \$300 for a full page, \$200 for a half page, and \$100 for a quarter page ad in the 2024 lowa State Shoot Program with Gun Clubs receiving a \$100 credit. Dick Wonick seconded it. Motion passed.
- State Teams and All American Plaques Dennis Wonick cannot beat the price from Shamrock.
 State Team plaques are \$40 and All Americans are just over \$23. Jack Gangwish moved to go with Shamrock Leathers for State Team and All American plaques, and Ryan Meier seconded it.
 Motion passed. Ryan will contact Bryan at Shamrock to order these.

New Business

SCTP Shoot

 Coach's Conference – Lindsey was not able to go, but Steve went to the meeting and provided information to the coaches that was valuable to them including items Lindsey needed him to go through. The \$200 for the trailer site hit a nerve with some coaches. The ISTA and DNR are setting up games for the one afternoon like the flurry/crazy quail machine. Steve is trying to figure out the number of targets we might use.

- Night Trap House Filling John hasn't heard back from Jim Wilmont.
- Targets We are going to need 5 trailer loads total, but we have 2 already in the shed. We need to get the traps off of the White Flyer pallets if we want to return them by March 25th. Ray Dentlinger moved to have Steve order one trailer load of targets in by March deadline and two other loads the Thursday or Friday before the SCTP Shoot, and Ryan Meier seconded it. Motion passed.
- Parking Crews It was suggested to shorten the amount of time the crews will be needed. Jack Gangwish moved to have parking crews from 6:30am to 10am with between the individuals working in a crew to recuperate the team trailer cost of \$200, and Ray Dentlinger seconded it. Motion passed.

Steve told the group Iowa was #6 in the nation for ATA targets thrown in 2023.

Next Meeting Date – The group will zoom the first part of February with a meeting in person in Cedar Falls on March 16th.

Jack Gangwish moved to adjourn the meeting, Ray Dentlinger seconded. Motion passed. Meeting was adjourned at 8:11pm.
