Abstract

The abstract contains the objectives of the study/research/development/thought outcomes, the methodology employed, the results of the study/research/development/thought process, and conclusions. It also includes the novelty of the study/research/development/thought outcomes and recommendations for the advancement of social sciences and humanities. An abstract is often presented separately from the article, so it must be able to stand alone. The abstract should avoid references and non-standard or unusual abbreviations, but if abbreviations are deemed essential, they must be defined at their first mention in the abstract. The abstract is written in continuous sentence form, forming a single paragraph (not in mathematical equations or formulas), without section titles (subheadings), footnotes, bibliographic citations, or abbreviations. The abstract should be 150–200 words in length (using 1.0 spacing and font size 10).

Keywords: 3-5 words or phrases, sorted based on their relevance to the title of the manuscript and its content, could be one-word or multiple-word phrase, does not contain abbreviations

Articles can be written in either Indonesian or English. Articles in Indonesian should adhere to punctuation and spelling rules outlined in the Enhanced Indonesian Spelling (Ejaan Yang Disempurnakan or EYD) Fifth Edition published by the Language Agency, Ministry of Education and Culture. Articles in English should follow international English language standards and rules.

Manuscripts are typed with 1.15 spacing on A4-sized paper using Calibri font size 12, with a minimum of 4000 words and a maximum of 8,000 words. The manuscript should be submitted as a Word document (.doc/.docx). The manuscript should not have been previously published in other media, should not be under consideration in another journal, and must be free from plagiarism. The Editorial Team uses Turnitin to check for plagiarism with a tolerance limit of 20%.

This section also incorporates a literature review comprising relevant theoretical studies and a review of previous research findings. The introduction concludes with the research framework, and its length is approximately 25 percent of the total article length."

This section provides details on the approach/methodology used in conducting the research. It is recommended to begin with the research approach, variables utilized, required data, data sources and selection methods, data collection and analysis methods, as well as the research limitations. This section constitutes approximately 10 percent of the total length.

RESULTS AND DISCUSSION (Heading 1)

This section encompasses the research findings that align with the research objectives and offers interpretations of these findings. The research findings are discussed, analyzed, elaborated upon, and interpreted in the context of achieving the research goals.

Second Level Sub Title (Italic, heading 3)

This section encompasses the research findings that align with the research objectives and offers interpretations of these findings. The research findings are discussed, analyzed, elaborated upon, and interpreted in the context of achieving the research goals.



CONCLUSION (Heading 1)

Conclusions are not a summary of research results but rather provide answers to the objectives. The formulation of conclusions uses data from the discussion and is consistent with the research problems and goals. Conclusions are written in paragraph form, not in bullet points or numbering. This section should constitute approximately 5-15 percent of the overall manuscript length.

ETHICAL STATEMENT AND DISCLOSURE (Heading 1)

Authors are required to state that the study was conducted in accordance with ethical principles, including informed consent, protection of informants' confidentiality, and respect for local cultural values. If the research involved vulnerable groups, please specify the protective measures taken to ensure their safety and equal participation. The statement should also disclose any sources of funding or declare that no external funding was received, along with a declaration of no conflict of interest. Authors must confirm that all data were collected through valid methods and have been verified for accuracy. If artificial intelligence (AI) tools were used, clarify that their use was limited to technical assistance such as language editing, without influencing the scientific content. Conclude with a sentence

stating that the authors take full responsibility for the content and conclusions of the article.

REFERENCES (Heading 1)

The authors must ensure that each reference in the text appears in the reference list and vice versa. Wikipedia, personal blogs, or non-scientific sites should not be used. All notes should appear as citations in anonymous citations in footnotes. The bibliography is compiled using the international standard American Psychological Association (APA) Style 7th edition with the assistance of applications such as Mendeley, Zotero, RefWorks, Endnote, and others.

The minimum number of references cited is 20, with a minimum of 80% from primary sources, such as articles published in scientific journals/magazines, dissertations, and theses, and a maximum of 20% from other sources, such as books, newspapers, magazines, etc.

The more up-to-date the cited references, the better. This journal requires that at least 80% of the cited references be publications from the last 10 years, and a maximum of 20% may include references older than 10 years, including classic (old) references used for historical studies.

or quotations longer than four lines, place the text in a free-standing block without quotation marks. Begin the quotation on a new line, with the entire block indented from the left margin.
