

# **Coinpedia Privacy Policy**

We at Coinpedia.org ("we", "us", "Website" or "Coinpedia") respect your privacy. This Policy ("Privacy Policy") is applicable to personal and non-personal client information obtained by Coinpedia via our Website, or any other source by which this Privacy Policy is related or referenced.

The Policy explains the types of information we acquire about the visitors of our Website ("You", "Your") and how do we use "said" information. We also explain the measures to protect the information security and how to contact us related to our privacy practices

## **1. Types of information we acquire**

### **1) Non-personal Information:**

- When you navigate to Coinpedia.org, our system acquires information about your use of our Website via automated ways including, but not limited to, web server logs, cookies, JavaScript and other similar technologies.
- The information we acquire or provided by the mobile devices you use to interact with the Website may include the pages visited, time of visit, and time spent on each web pages page; citing site details (like the website name, the searching system name, the social network name etc.); the type of browser language, web browser, JavaScript support, type of operating system, network location and IP address, the flash version, screen resolution, and screen color processing ability, form submission errors, downloading files, clicks on external links and video on the Website, scroll depth, geolocation information, communication with Website widgets.

### **2) Personal Information**

- In some cases, we may gather personal information voluntarily provided by you, such as your email and name. Without your consent, we do not collect or process your personal information.
- By voluntarily providing us your personal information, including, but not limited to, by accessing the Website, you expressly agree to our use of your personal information in agreement with this Privacy Policy. If you are

providing personal information to us, you agree and acknowledge that such personal information may be carried out from your current location to the Website servers and to the authorized third-parties servers.

### **3) Additional Information:**

- On the timely basis, we reserve the right to acquire the information about legal entities that navigate through our Website, via their representatives.
- We may acquire information about the legal entity's website, the name of the legal entity, the legal entity's contact information, the country of incorporation.

## **2. How we gather the information?**

- We may gather personal identification details such as your name and email from your side only if you voluntarily submit such details to us. You always have the power to refuse to provide the personal identification information. We may gather your non-personal identification information whenever you communicate with our Website.

## **3. How do we use the information we acquire?**

1) We use your non-personal details for the following purposes:

- To prevent you from facing unnecessary advertisements or asking you to re-enter the Website more than it is necessary;
- to evaluate the aggregate number of visitors navigating our Website;
- to enhance the content of our Website and to customize the layout of our pages together with the content;

- You have to right to control and/or delete cookies according to your preference. You can delete all the cookies from your system and you can set many browsers to protect them from being saved therein. However, if you do this, some Website services with functionalities might not work.

- We will keep your information as long as we need to give you services or to complete our legal obligations. We will keep and use the information you provided as essential in accordance with our legal obligations, to settle disputes, and impose our agreements.
