11:50am	As a presidential candidate, Biden promised to reduce ICE detention and end contracts with private prison companies. But as president, his administration has only canceled two detention contracts in the whole country; has renewed and expanded ICE contracts with private prison companies and local jails; has fought a court case against California's attempts to end privatized ICE detention; and has presided over a massive increase in the number of detained immigrants from January to November 2021. Given the Biden Administration's surprising intransigence, many activists in Virginia and across the country are turning to state- and even local-based strategies to end immigration detention.
