

PREAMBLE.

Therefore, we strictly adhere to all applicable data protection procedures regarding the complete and comprehensive security of your personal data. We are merchants - developers of software and applications "Applications for happy people", which owns "Fall in love, step by step instructions".

This Privacy Policy explains how we use any personal information you provide to us or collect about you, and what happens to it when you use the Program. As a rule, data processing is not our main and direct goal of doing business. Most of the time we act as Subprocessors with your Personal Data previously obtained from third-party personal data controllers like Google. Pursuant to this Privacy Policy, you may receive additional information about our processes through the processing of personal data

IN WHAT WAY DO WE USE YOUR PERSONAL DATA?

We use your personal information to make "Fall in love, step by step instructions" work quickly and efficiently. These types of data may be stored by third parties. Therefore, we neither keep, nor store these types of data on our servers.

We require your consent to grant you further access to "Fall in love, step by step instructions" and to ensure robust and consistent Application performance and to be compliant with legal requirements. We are not intended to collect and (or) process your Personal Data until obtaining your clear and active consent.

HOW DO WE SHARE AND DISCLOSE YOUR DATA?

We may share your personal data under the following conditions: Safety, Legal purposes, and Law enforcement. We will disclose your personal data to third parties to the extent necessary to:
