What Do We Mean by 'Segregation'

When you say 'segregation', are you talking about...

...an outcome?

(for instance, a substantial difference in the racial composition of two adjoining neighborhoods)

...or a process?

(for instance, "steering" by real estate agents of white clients to predominantly white neighborhoods, and black clients to predominantly black neighborhoods.)

When you say 'segregation', are you talking about...

• ...a policy or practice that specifically and intentionally excludes black, brown or non-white persons from certain spaces or amenities?

(for instance, designation of public certain schools as "whites only" by a local Board of Education.)

 ...or do you mean any policy or practice that has the effect of excluding black, brown or non-white persons, regardless of intent?

(for instance, drawing of local school boundaries so that some schools are fed by predominantly white neighborhoods, and others are fed by predominantly black neighborhoods.)

When you say segregation, are you talking about...

• ...A pattern of separation by race that is clearly disadvantageous to most or all black, brown or non-white persons and clearly advantageous to most or all white persons?

(for instance, neighboring school districts, one predominantly white, the other predominantly black, in which per-pupil spending in the predominantly white district is substantially higher than in the black district.)

• ...Any pattern of separation by race, even if its differential impacts are mixed or ambiguous?

(for instance, neighboring legislative districts, one majority-black, one majority-white, where the majority-black legislative district enables the frequent election of black representatives to the legislature.)



Racial Composition by Tract..."Representative" and "Non-Representative" Tracts

About 15% of Monroe County residents identify as Black or African-American...

Racial Composition of Monroe County
ACS 2018 5-Year Estimates



If the county were not segregated, would the composition of each tract be roughly the same as the composition of the county as a whole?

Classify tracts as follow:


- Disproportionately White Tracts: <5% of residents black.
- Representative tracts: 5% 25% of residents black.
- Disproportionately Black Tracts: 25% 50% residents black.
- Extremely Disproportionately Black Tracts: >50% of residents black.

The Distribution of "Representative" and "Disproportionate" Tracts Across Physical Space


