7. Specific items for discussion

1. Ward Councillor Bambridge update here

- 1 I note that in the agenda for Monday's meeting there is an item on the situation with Stuart Ryall and the agricultural building on Brackley Lane. I had contact with him three weeks ago, following my earlier email containing the photos I was given at your meeting. He replied "Thank you for sharing the photographs. We have been able to view and download copies for our records. We will review as a team and update you after we have agreed our next step/s." I will chase for a reply if I don't hear anything very soon.
- 2 Also listed is an update on the meeting I attended with Silverstone circuit, where the following points were highlighted -
 - New pricing to discourage parking at Silverstone and encourage bus use to reduce local traffic. There will be more buses linking surrounding rail stations and a lower bus price of £5 per person. By mid-September, 60% of Grand Prix tickets had been sold with more booking shuttle buses than previously (last year over 63,000 used the shuttle buses of which 27,000 were on the Sunday).
 - Uncertainty regarding the completion date of the roundabout on the A43 for the Towcester Relief Road (construction of which has already commenced), is making a delay for detailed traffic planning a possible issue.
 - Construction of the new karting circuit on the infield of the main circuit has started. This will be used for leisure karting as well as for racing and tuition.
- 3 DHL has appealed the dismissal of its planning application at Bell Plantation and attached is the letter from the inspectorate setting out details of the process.
