Rationale: The current Bylaws mention Site Selection Vote exactly once in 24 pages. This mention is in Article VIII, 11.1 about the General Assembly. This is turn means that the General Assembly, and only the General Assembly decides on the host of the Gay Games as the Site Selection vote is nowhere else to be found in the Bylaws. The bylaws should contain more clarification on the Site Selection Vote, It is proposed to be clear that the voting on the Presumptive Host for Gay Games is the sole responsibility of the General Assembly. It is also proposed to add that the Board should have the authority to approach the runner up or third placed if necessary, either because the host/presumptive host is unable or unwilling to host the Gay Games.

VIII 11 POWERS: The General Assembly will have the following decision making authories: 11.1 GAYGAMES SITE SELECTION 11.1.1 Only Full Member Organisations in good standing who have had one or more Delegates present at the prior Annual General Assembly or at two of the past four Annual General Assembly meetings shall be eligible to vote on Gay Games site selection matters.

11.1.2 All Directors/Officers who are present at the meeting shall be eligible to vote on Gay Games site selection matters

11.1.3 Full Member Organisations whose memberships are terminated during the four year period prior to a site selection meeting

## **Proposed New/Updated Bylaw**

VIII 11 POWERS: The General Assembly will have the following decision making authories: 11.1 GAYGAMES SITE SELECTION 11.1.1 Only Full Member Organisations in good standing who have had one or more Delegates present at the prior Annual General Assembly or at two of the past four Annual General Assembly meetings shall be eligible to vote on Gay Games site selection matters.

11.1.2 All Directors/Officers who are present at the meeting shall be eligible to vote on Gay Games site selection matters

11.1.3 Full Member Organisations whose memberships are terminated during the four year period prior to a site selection meeting





shall not be eligible to vote on Gay Games Site Selection matters. 11.1.4 Associate Member Organisations shall not be eligible to cote in site selection matters	shall not be eligible to vote on Gay Games Site Selection matters. 11.1.4 Associate Member Organisations shall not be eligible to cote in site selection matters 11.1.5 In the circumstances where the presumptive host or host is unable or unwilling to host the Gay Games, the FGG Board of Directors can approach the runner-up or third places.
