- Called to Order by Jason at 6:33 PM
- Previous Minutes approved (Link) motion by Tracy, second by Tom.
- President's Report (Jason Byrne)
 - He presented his direction for the Longwood Historical Society and proposed changes. One of the items he stated was a push for more technology. He also wants to work on the society's growth.
- Vice President Report (Tracy Putnam)
 - She confirmed the date of the Poker Tournament as March 29th and is waiting for the City Council to approve the use of the building on that date. Tracy will also assist with ensuring committees are up to their responsibilities.
- Finance and Trustee Report (Tom Redditt/Susan Hudson)
 - Tom gave the finance report. There were expenses for the repair of a locked bathroom door, a/c repairs, tree clean-up behind the HCC, a new refrigerator, and a re-do of the sprinkler system.
 - Suzy Hudson identifies the breakdown of the deposits.
 - Rahil, our accountant, has been given the authority to look at our bank accounts to assist with our 501C. Butch Bundy gave a \$500 quote on the wood repair to the front of the HCC, but we need two more quotes.
 - The upper roof quote for the Bradlee-Mac by HI-Low is \$53,180. We still have to do a lot more save to be able to do that.
 - Tom Redditt is looking for a place for the Society to make interest on its funds. So far, he has found Fidelity, which will allow the Society to open a money market and use it if necessary without a penalty.
