

# Privacy Policy

Camila Lindsay (“Us”, “We”, “Our”) operates an Air Finder, Device Tracker App. This page informs You of Our policies regarding the collection, use, and disclosure of personal data when You use Air Finder, Device Tracker App and the choices You have associated with that data. We use Your data to provide and improve Air Finder, Device Tracker App. You mean the individual accessing or using Air Finder, Device Tracker App, or the company, or other legal entity on behalf of which such individual is accessing or using Air Finder, Device Tracker App, as applicable. By using Air Finder, Device Tracker App, You agree to the collection and use of information in accordance with this policy.

## Collecting and Using Your Personal Data

### Types of Data Collected

#### **Personal Data**

While using Air Finder, Device Tracker App, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

- Email address
- Usage Data
- Photo and video data
- Approximate location data

Usage Data is collected automatically when using Air Finder, Device Tracker App.

Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, unique device identifiers and other diagnostic data.

When You access Air Finder, Device Tracker App by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile Internet browser You use, unique device identifiers and other diagnostic data.

We may also collect information that Your browser sends whenever You access Air Finder, Device Tracker App by or through a mobile device.

#### **Information Collected while Using Air Finder, Device Tracker App**

While using Air Finder, Device Tracker App, in order to provide features of Air Finder, Device Tracker App, We may collect, with Your prior permission:

- Information regarding your location

- *Pictures and other information from your Device's camera and photo library*

*We use this information to provide features of Air Finder, Device Tracker App, to improve and customize Air Finder, Device Tracker App. The information may be uploaded to Camila Lindsay's servers and/or Air Finder, Device Tracker App Provider's server or it may be simply stored on Your device.*

*You can enable or disable access to this information at any time, through Your Device settings.*

## *Use of Your Personal Data*

*Camila Lindsay may use Personal Data for the following purposes:*

- *To provide and maintain Air Finder, Device Tracker App, including to monitor the usage of Air Finder, Device Tracker App.*
- *To manage Your Account: to manage Your registration as a user of Air Finder, Device Tracker App. The Personal Data You provide can give You access to different functionalities of Air Finder, Device Tracker App that are available to You as a registered user.*
- *For the performance of a contract: the development, compliance and undertaking of the purchase contract for the products, items or services You have purchased or of any other contract with Us through Air Finder, Device Tracker App.*
- *To contact You: To contact You by email, telephone calls, SMS, or other equivalent forms of electronic communication, such as a mobile application's push notifications regarding updates or informative communications related to the functionalities, products or contracted services, including the security updates, when necessary or reasonable for their implementation.*
- *To provide You with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless You have opted not to receive such information.*
- *To manage Your requests: To attend and manage Your requests to Us.*
- *For business transfers: We may use Your information to evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Data held by Us about Air Finder, Device Tracker App users is among the assets transferred.*
- *For other purposes: We may use Your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve Air Finder, Device Tracker App, products, services, marketing and your experience.*

*We may share Your personal information in the following situations:*

- *With Service Providers: We may share Your personal information with Service Providers to monitor and analyze the use of Air Finder, Device Tracker App, to contact You.*

- *For business transfers: We may share or transfer Your personal information in connection with, or during negotiations of, any merger, sale of Camila Lindsay assets, financing, or acquisition of all or a portion of Our business to another company.*
- *With Affiliates: We may share Your information with Our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include Our parent company and any other subsidiaries, joint venture partners or other companies that We control or that are under common control with Us.*
- *With business partners: We may share Your information with Our business partners to offer You certain products, services or promotions.*
- *With other users: when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.*
- *With Your consent: We may disclose Your personal information for any other purpose with Your consent.*

### *Retention of Your Personal Data*

*Camila Lindsay will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.*

*Camila Lindsay will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Air Finder, Device Tracker App, or We are legally obligated to retain this data for longer time periods.*

### *Transfer of Your Personal Data*

*Your information, including Personal Data, is processed at Camila Lindsay's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.*

*Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer.*

*Camila Lindsay will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of Your data and other personal information.*

## *Delete Your Personal Data*

*You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.*

*Air Finder, Device Tracker App may give You the ability to delete certain information about You from within the Air Finder, Device Tracker App.*

*You may update, amend, or delete Your information at any time by signing in to Your Account, if you have one, and visiting the account settings section that allows you to manage Your personal information. You may also contact Us to request access to, correct, or delete any personal information that You have provided to Us.*

*Please note, however, that We may need to retain certain information when we have a legal obligation or lawful basis to do so.*

## *Disclosure of Your Personal Data*

### ***Business Transactions***

*If Camila Lindsay is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.*

### ***Law enforcement***

*Under certain circumstances, Camila Lindsay may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).*

### ***Other legal requirements***

*Camila Lindsay may disclose Your Personal Data in the good faith belief that such action is necessary to:*

- *Comply with a legal obligation*
- *Protect and defend the rights or property of Camila Lindsay*
- *Prevent or investigate possible wrongdoing in connection with Air Finder, Device Tracker App*
- *Protect the personal safety of Users of Air Finder, Device Tracker App or the public*
- *Protect against legal liability*

### ***Security of Your Personal Data***

*The security of Your Personal Data is important to Us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While We strive to use commercially acceptable means to protect Your Personal Data, We cannot guarantee its absolute security.*

## ***Children's Privacy***

*Air Finder, Device Tracker App does not address anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13. If You are a parent or guardian and You are aware that Your child has provided Us with Personal Data, please contact Us. If We become aware that We have collected Personal Data from anyone under the age of 13 without verification of parental consent, We take steps to remove that information from Our servers.*

*If We need to rely on consent as a legal basis for processing Your information and Your country requires consent from a parent, We may require Your parent's consent before We collect and use that information.*
