



THE CONSTITUTION OF THE DISTRICT OF SAN VOOPERISCO

September, 2nd 2020

The People of San Vooperisco

PREAMBLE

"San Vooperisco is and shall be, a land of freedom and opportunity. As such, all San Vooperiscans agree upon the following articles. In the case that disagreements threaten this Unity, it is lawful for the governmental implements detailed below to be used to rectify the problems seen by the San Vooperiscan People through Fair and Justified means."

ARTICLE I

The Legislature

1. The Legislature shall act as the legislative branch in our district government. Made up of 7 Representatives. They shall act as the body who votes on bills presented in the District Legislator. Bills can be created by anyone but must be proposed by a member of our district government. The Governor shall act as the head of the legislature.

2. Members of the legislature shall be voted in by the people of San Vooperisco and the top seven candidates shall win the election.
 - a. The legislature shall have a 1-month term
3. The Governor shall be elected by the people, and a simple majority is all that is needed to win the position.
 - a. The Governor shall have a 1-month term
4. The legislature must achieve $\frac{3}{4}$ of the vote for the passing of an amendment and a simple majority for a bill. The passed bill must have the signature of the Governor or Senator to come into effect. An amendment requires both the signature of the Governor and Senator.

The Judicial Branch

5. The San Vooperisco Chief Judge is the head of the Judicial branch. The Chief Judge is appointed by the senator of our district and is in charge of the District Court.
6. On the monthly ballot where citizens vote for the Governor and Representatives, there shall be one section where citizens can choose to retain the Chief Judge.
 - a. Citizens can choose a "Yes" or "No" answer to this. If there is a simple majority of "No's" then the Chief Judge may be removed and the Senator may follow the proper steps to appoint a new one.
7. The District Judicial Branch is made up of 3 members: the Chief Judge, District Sheriff, and Attorney General. The Chief Judge is appointed by the Senator/Governor and must be approved by a simple majority in the Legislature.
8. The District Court needs a simple majority to prosecute someone.
9. When an entity commits a crime that is unique to the district, the district judge can have the final verdict and the Attorney General shall prosecute that entity accordingly. If the crime is above the jurisdiction of the District Judge, the Federal courts shall deal with the matter.

10. To enforce our laws, San Vooperisco shall have a District Attorney General, whose job it shall be to prosecute and initiate all cases against rule-breakers. Which shall be prosecuted in the District Judges court, and the event that the case is brought to a higher court.
11. The Attorney General shall be appointed by the District Judge, and confirmed by a simple majority in the Senate and approved by one of the 2 executives.
12. The District Court may choose to impeach any official (exempting the Senator) for inactivity.
13. It shall be the job of the District Court to certify all elections within the District of San Vooperisco, the court shall act as an independent body when certifying the election and shall be afforded the full data on the election. They may order a hand recount and finally may certify the election with a simple majority vote.

The Executive Branch

14. The Governor is the head of the executive branch. The Senator acts as our district's representative in the federal government.
15. The Senator is elected by the people of San Vooperisco. A simple majority of the vote is all that is needed to declare an official victory.
16. While being the representative of the district in the federal government, the Senator also has duties and power within the district government. The Senator is required to approve an amendment before it comes into effect, while a bill can be approved by the senator themselves or the Governor.
17. The Senator may veto bills.

ARTICLE II

Rights afforded to all San Vooperiscans

1. The right to safety, from both internal and external forces. The San Vooperiscan Military shall be used to enforce this safety afar, and a Vooperian Police force shall ensure safety locally.
2. The right to privacy, including privacy from the government's surveillance and to keep private property to one's self
3. The right to self-defense, including the right to arm oneself with a single-target weapon such as a rifle or sword
4. The right to free speech, by which the government may be criticized by a free press and a citizen may represent and present themselves how they wish
5. The right to challenge the government, whether through court or by running for office to change unsuitable conditions. In a court case, the Attorney General shall represent the government.
6. The right to a fair trial in a court of law, run by impartial judges who are reasonably chosen
7. The right to life, liberty, and happiness, unlimited by the government and extended to the best of its ability
8. The right to run for office
9. The right for entities to reside in a non-toxic community, to not have slander and false claims be accused towards them.
10. The rights that are not listed in the Constitution belong to the citizens of the districts, and not the government.

Any infringement of these rights can be brought up in a court of law and may be appealed to the point of the San Vooperiscan District Court. At this point, a consensus must be reached.

AMENDMENTS

1. First Amendment

The Senator shall choose how they wish to vote in the Senate. The Legislature is entitled to overturn the vote of the Senator and decide how the District will cast its vote with a simple majority.

2. Second Amendment

Representatives may be impeached for failure to represent their people, do their duties, uphold the law, or implement this Constitution.

1. By a $\frac{3}{4}$ majority of the Legislature, excluding the Representative of which it's about.
2. In the event of an Emergency, unanimously by the Governor, Senator, and Chief Judge.

The Governor may be impeached for failure to represent the people, do their duties, uphold the law, or implement this Constitution.

1. By a $\frac{3}{4}$ majority of the Legislature, excluding the Governor.
2. By a majority of the Consul Members by declaration that the Governor is unable to discharge the powers and duties of their office.

The Chief Judge may be impeached for failure to maintain impartial justice, do their duties, uphold the law, or implement this Constitution.

1. By a $\frac{3}{4}$ majority of the Legislature
