
Rockingham Cambio Cumbre Futsal Club

By-Laws





- 2. **Advertising** of or for any commercial product or enterprise is not permitted at any time except with written approval from the Management Committee.
- 3. **Notices:** No notices or advertisements may be posted on the club premises notice boards or elsewhere in the club except by or with authority of the General Manager.
- 4. **Removal of Club Property:** No member shall take away from the Club any of its property other than as authorised by the Management Committee.
- 5. **Property:** All Members and guests are required to treat all Club property and facilities with proper care. Members shall be required to pay for any of the Club's property they destroy or damage. The cost of replacing or repairing such loss or damage shall be determined by the Management Committee, whose decision shall be final.
- 6. **Dress Code:** Members and their guests shall be suitably attired whilst inside the Clubhouse. The minimum standard of dress shall be:
 - Shirts, trousers, skirts, dress shorts and footwear supporting neat casual clothing must be worn.
 - Gentlemen are required to wear a collared, polo or crew neck shirt.
 - Women are required to wear neat casual clothing at all times and footwear is to be of a standard supporting neat casual dress.
 - Thongs, tank tops, singlets, bathers, scanty attire, or clothing with offensive slogans or artwork are not to be worn inside at any time.
- 7. No persons shall use bad or questionable language in the Club premises at any time.
- 8. Members are expected to show guests every consideration with particular emphasis on occasions where competitions are in progress. Riotous behaviour will not be tolerated under any circumstances.
- 9. Each Member shall be responsible for the dress and the behaviour of their guests.
- 10. There is no smoking permitted in the Club premises.
- 11. All vehicles must be parked within the marked bays.
 - The Club car park is for the use of members only while they are enjoying the facilities of the club and for approved staff and contractor vehicles.
 - Members and guests shall not park in the staff's bay

- 12. Parking violations will result in suspension of membership.
- 13. No dogs or other pets are permitted in or on Club premises.
- 14. Members or persons under the age of 18 years must be accompanied by, and under the supervision of a responsible adult.
- 15. There shall be no bar trading outside of the advertised hours.
- 16. There shall be no illegal gambling of any kind.
- 17. All persons must vacate the premises not longer than 15 minutes after the advertised hour for the cessation of trading.
- 18. Any person can and will be refused bar service, if, in the opinion of the person on bar duty or any Member of the Management Committee, consider that further service is unwarranted.
- 19. Any person asked by the person on bar duty or any Member of the Management Committee to leave the premises shall do so without question.
- 20. No person shall enter the area behind the bar unless properly authorised to do so. No person shall use the area behind the bar as an access to another area of the premises or to utilise any facility.
- 21. No person shall remain in or obstruct free access to that area set aside for service only.

NOTE: Any breach of these house rules may lead to the suspension of the offending Member or Members.
