## **Florence Elementary Student Walkers**

Students in grades 3-5\* who live on the following streets may walk or ride non-motorized transportation (bike, scooter, etc) to and from school with parent permission:

At no point should students be walking along or crossing US 42, Turfway Rd, Dixie Hwy, or Ewing Dr. We do not have a safety officer to ensure safe crossing of students on these roads.

All students who walk home should report to either the cafeteria or upstairs bus loop when parent pick-up students are called. They will be dismissed from the cafeteria by a teacher after all parent pick-up cars have left the lot.

All students who are walkers must abide by the rules and have a signed paper by the parent/guardian that they have permission to walk home or to school.

The principal or designee has the right to refuse at any time for a student to walk home or to school.

\*Students in grades K-2 may walk home with an older sibling if they have parent and principal permission.
