Abstract contents are shaded with THEME COLORS: White, Background 1, in Darker 15%.

Keywords: word 1, word 2, word 3 Keywords are placed under the abstract containing 3-5 words in italics (Italic) oriented *the Medical Subject Headings* ([MeSH](#)).

The main manuscript is written using Bookman Old Style 11 spaced 1 with one column layout. The title of the word 'Introduction' and etc in the complete article is typed with CAPITAL letters at the beginning of the word written in **Bold**.

Introduction

Should provide a context or background and specify the purpose of the study or observation. No more than two pages long.

Methods

Must indicate enough detail for others to be able to replicate the study. All details of the plan of study including type of study, population and sample, inclusion and exclusion criteria, sample size, sample recruitment, settings, instruments, etc should be mentioned. All data analysis methods should be described clearly in this section. Methods and software of statistical analyzes used and the criteria for determining significance levels should be described.

Results

Should be presented in chronological sequence in the text, table, and illustration then organize the results according to their importance. Repetition of data already given in tables and figures should be avoided. The provisions for tables and figures are as follows: the word picture or table is written in Bold with Bookman old style 11 writing, using an open table model, the title of the table is above the table, the title of the picture is below the picture and the description of the table is written below the table with footnotes using the symbol a, b, c, etc, writing Bookman old style 9.

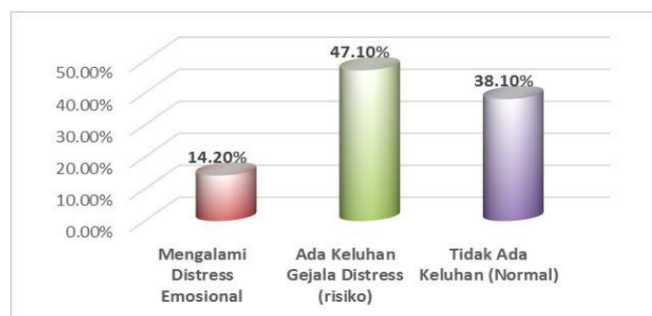


Figure 1. Overview of Emotional Distress Events
