Old Business

2. Elizabeth informed the board of a joint spring break trip with the band.
 - a. The trip will be one night to Biltmore.
 - b. She is working with a travel agent who provided an estimate of \$321/person for lodging, transportation, one supper, and Biltmore House admission.
 - c. The band and 2 choirs (Chamber and Aurelia) will perform. The band estimates 60 band students would attend.
 - d. Discussion was held on various logistics including:
 - i. The current OCS maximum limit for students to chaperone ratio is 8 : 1.
 - ii. Breakfast and/or lunch could be donated from families of students, depending on whether the hotel offers continental breakfast.
 - iii. The Band Boosters could also provide support.
 - iv. Insurance needs to be considered/obtained.
 - v. Collection of funds seems to depend on if the trip is classified as a school field trip. If so, per Dr. Hipps, funds are collected by Debbie Kembrell (unsure of spelling).
 - vi. Elizabeth to check with Tracy Carver if she can attend as a medication dispenser.
