MathSoc follows a modified version of Robert's Rules to help keep our meetings orderly. They prevent us from talking over each other. Please wait to be acknowledged before speaking. For each speaking turn focus on a single point. Everyone has the right to speak. For a motion to be discussed it needs a "mover" and a "seconder".

If you wish to:

- Make a new point \rightarrow 1
- Reply as part of the ongoing conversation $\rightarrow 2$
- Ask information about the speaking order, or relevant bylaws, or policies → POI (Point of Inquiry)
- When you see someone else not following the speaking order → POO (Point of Order)
- If you couldn't hear or need to take a break, etc. → POP (Point of Personal Privilege)

Most motions at Council aren't controversial, so we generally use a method of voting where you only need to explicitly vote if you wish to vote against a motion or abstain from voting. You can



ask to have your vote noted in the minutes. We can also use roll-call voting or ballot box voting if $\frac{2}{3}$ of Council agrees to it or if the speaker decides it is appropriate.

5.1 FARMSA S22, F22, and W23 Subscription Reimbursements — *VP Zhang, VP Tania*

5.2 PMC Social Cap Increase — VP Zhang, Councillor Huang

Whereas PMC's membership has grown to 108 MathSoc members:

Whereas PMC's social cap should increase as a result of this membership increase;

Be it resolved that PMC's social cap rises from \$476.00 to \$604.80 and the increased amount is allocated to line 54 (EOT) budget in PMC's budget.

5.3 ActSci Club Social Cap Increase — VP Zhang, VP Mustatea

Whereas ActSci Club's membership has grown to 185 MathSoc members; Whereas ActSci Club's social cap should increase as a result of this membership increase; Be it resolved that ActSci Club's social cap rises from \$962.00 to \$1202.50 and the increased amount is allocated to line 87 (EOT) budget in ActSci Club's budget.

5.4 ActSci Club: \$400 for Transition Dinner — VP Zhang, Councillor Pei [Tabled]

Whereas the ASC will transition to new executives and require improvements to the hand-over process between teams;

Be it resolved that the ASC recruitment is updated to reflect that ASC has a \$400 budget increase allotted for a transition dinner between Winter and Spring 2023 senior executives (2 presidents, 10 VPs).

5.5 FARMSA Exceeded Social Cap by \$75 [Discussion] — VP Zhang, VP Mustatea

Whereas FARMSA exceeded their social cap of \$250 by \$75;


Whereas MathSoc VPF and Council overlooked the social cap violation at the budget meeting; **Be it resolved that** Council discusses this violation.

5.6 Requesting Budget to Buy Stickers for Orientation — *VP Mustatea, VP Tania*

Whereas MathSoc would like to purchase stickers to be sold at the Office and be given out in the 2023 Orientation kits;

Whereas the expense will be split amongst the VPO's Novelties and Orientation Expense lines; **Whereas** a total of 2000 stickers is to be purchased with 1600 being dedicated towards orientation and the remaining 400 to be sold at the office:

Whereas StickerMule provides a quoted value to be \$455;

Be it resolved that Council approves \$380 (80% of \$455) to be added to the Orientation Expense line.

5.7 MGC Honoraria — Councillor Girardin, VP Neely

Whereas it is difficult for any party to decide honoraria for the MGC chairs, given that Council may not be privy to the chairs' performance and the Committee may not be qualified to evaluate itself as the amount of non-chair members may be small;

Whereas the MGC chairs receive free tickets to the Math Grad Ball for their work;

Whereas not all relevant sources were consulted before passing *Policy 18.9 — Honorarium* at the last meeting; and

Whereas MGC Chairs Eva Yang and Grace Feng did not receive free tickets; then

Be it resolved that Policy 18.9 — Honorarium is rescinded; and

Be it further resolved that MGC Chairs Eva Yang and Grace Feng are each reimbursed \$79.10 for the cost of their Math Grad Ball tickets.
