## **Section 1 > Introduction**

The following is an official report from the Audit and Accountability Committee outlining the findings and conclusions made during the course of an inquiry, certified by Audit and Accountability Command.

The subjects within this case are three accounts with two of them being suspected of being alts of the first one. The accounts are "xXParxityxX", "burgerhunter2000", and "KbrineplayzYT". All three individuals are involved within Paragon Research Institute, though only two of them are actually inside the Discord server. It is worth noting that all three used to hold the rank of Junior Researcher inside the Scientific Department, although one of them did leave the Scientific Department, specifically xXParxityxX. It should also be noted that one of their accounts, specifically burgerhunter2000, has been Class-E'd by the Foundation. The account "KbrineplayzYT" seems to be linked to the Discord account "PARXITY#0848." There is no separate main account that the alternate accounts are connected to. Furthermore, there is almost no way to determine which is the main account, or if there is one.

This release is a public version of the inquiry's final report, in accordance with the Transparency Policy of the Committee. Various information has been censored or redacted entirely for the privacy of the compulsory correspondents contacted during this inquiry, as well as any restricted information not pertinent to public interest.

## Section 2 > Methodology

The way the Committee caught wind of this was due to a report that we received through our ticket system. While the Committee did not gain any real evidence from it, we've concluded that both individuals are the same person or alternate accounts of one individual. The reasoning behind this was due to one account having a display name that replicated the original account. This pattern continues to the third account later on. In order to gain clarity, a hearing was conducted.

A hearing notice was sent to the Discord account affiliated with <u>xXParxityXx</u>, but there was no response after two days. Due to the already substantial evidence, the panel concluded that all of the mentioned accounts were linked and therefore alternate accounts.

## <u>Section 3 > Inquiry Findings</u>

The evidence below was all gained by observations on the Roblox website and in the discord servers and did not involve a hearing.

To start off, the reason why this entire Criminal Inquiry was created was due to a tip that we received within our Ticket System. They concluded that they were alt accounts due to a variety of reasons. All accounts received the display name "xXParxityXx" and seem to circulate every couple of weeks or so. We might also add that two of the accounts joined the Paragon and ScD Server on the same date, specifically "xXParxityXx" and "burgerhunter2000". Finally, both accounts seem to have similar descriptions on Discord in some form.

## Section 4 > Panel's Conclusions

### **Executive Summary**

To summarize, three individuals were suspected to be alts of some form, these three would be <a href="xXParxityXx">xXParxityXx</a>, burgerhunter2000, and KbrineplayzYT. While we gained sufficient enough evidence, we've decided to try and conduct a hearing with the individual, specifically with the account named <a href="PARXITY#0848">PARXITY#0848</a>. While the individual did not answer or respond to the hearing, we've decided that we have a sufficient amount of evidence to conclude this CI, which leads to our Prosecutorial Recommendation.

#### **Prosecutorial Recommendation**

After careful consideration, the audit panel has deemed it necessary that all involved accounts receive a **Foundation Exile** from the **Ethics Committee**, in accordance with *CoE 3.51 and 3.53* [Alternate Accounts].
