

## **FEE AGREEMENT TERMS**

### **Premier U14-U17 Boys & Girls**

By accepting a roster spot on a Premier Basketball Club team, the Player and Parent/Guardian named in the registration form (collectively the "Participant") hereby agree to this Fee Agreement and will pay the following fees associated with their participation on a Premier Team.

For U9-U13 participants, this is a 12 month commitment with a 4 month spring/summer season (April-July) and a 6 month fall/winter season (September-February). After spring/summer players may "opt-out" of the fall/winter by notifying Premier Basketball by August 1 each year. ***Participant is responsible for payment until a suitable replacement player is found IF possible.***

For U14-U17 participants, this is a 5 month (March-July) commitment. Should Participant leave her/his team during the respective season for any reason other than a season-ending injury or moving out of her/his home state during each season, ***Participant is responsible for payment until a suitable replacement player is found IF possible.***

There are no Premier activities for high school players scheduled in June and this break is taken into consideration when fees are determined.

Season fee structure:

- First payment is non-refundable, due in March, and signifies the participant's commitment to the roster spot offered.
- The cost of the season may be paid in full or divided into 5 payments (March-July) for spring/summer and 6 payments (September-February) for fall/winter. The fall/winter league/tournament registration fee will be charged on August 15 unless notified by August 1 that participant "opts-out" for fall/winter season.
- ***The fall/winter season fees DO NOT include the cost of winter leagues that will be charged in addition to the fees listed for the fall/winter season.***
- The cost of the season includes event registration fees and coach's travel fees. All players pay these fees regardless of tournament attendance. ***Fees are subject to change if events are added, modified, or dropped.*** Player insurance is also included.
- In addition to these payments, players are responsible for travel costs and arrangements.
- Spring/summer fees must be paid in full by August 1 and fall/winter fees paid in full by February 28.

***Participant agrees and acknowledges that should Participant leave their team prior to August 1 for spring/summer season for reasons other than the Player suffering a season-ending injury or moving out of their state of residence when accepting the roster spot, Participant is still required to fulfill the financial obligations in this Fee Agreement.***

A \$35 Collection Fee will be charged to all past due accounts requiring collection. The Participant fully understands that they will be ineligible to play unless their account is in good standing or a payment arrangement has been made and agreed upon with Premier staff. A 10% surcharge will be deducted from all refunds.

If any legal action, arbitration, or other proceeding is brought for the enforcement of this Agreement, or because of an alleged dispute, breach, default, or misrepresentation in connection with any of the provisions of this Agreement, the prevailing party shall be awarded all costs and reasonable attorneys' fees incurred in that action or proceeding, in addition to any other relief to which it may be entitled.
