

COOKIE POLICY

Last update: May 2023

1. PURPOSE

HANTY SYSTEMS, S.L. (hereinafter referred to as "HANTY", "we", "our", "ours", "us"), wants to offer you as a user (hereinafter referred to as the "User", "you", "yourself", "yours"), a secure experience and service in our web environments located at the addresses https://web.hanty.app (hereinafter the "Web Page") and https://app.hanty.app/ (the "Platform") (both web environments collectively referred to as the "Website").

Consequently, we have implemented this Cookie Policy, which complies with the security measures required by Organic Law 3/2018, of December 5, on the Protection of Personal Data and guarantee of digital rights ("LOPDGDD"), the European Regulation on the Protection of Personal Data 679/2016, of April 27, regarding the protection of individuals with regard to the processing of personal data and the free movement of such data ("GDPR"), and Law 34/2002, of July 11, on information society services and electronic commerce ("LSSICE"). All of this is aimed at ensuring your privacy and being transparent about the use of your data.

Although **HANTY** is subject to Spanish laws, we want to assure our Users that our Cookies Policy is fully compliant with Swiss law, specifically the Swiss Federal Act on Data Protection ("FADP"). Additionally, it is important to note that we adhere to the stricter regulations set forth by GDPR which provides comprehensive protection for personal data and imposes more stringent requirements compared to the FADP. By aligning our privacy practices with the GDPR, we aim to prioritize the highest standards of data protection, even when not explicitly required by Swiss law. Rest assured that **HANTY** takes data privacy seriously and is committed to upholding the principles and requirements outlined in both the Swiss FADP and the GDPR. We continuously review and update our privacy practices to ensure compliance with relevant regulations and to safeguard your rights and privacy.

In line with the aforementioned, in order to facilitate your navigation on the Website, we inform you that we use cookies or other similar data storage and retrieval devices (hereinafter referred to as "Cookies"), and where we act as Data Controllers of your data in accordance with the GDPR and the FADP. In this Cookie Policy, we will explain: (i) what cookies are, (ii) what types of cookies we use on our Website, and (iii) how you can configure or disable them.

3. ¿WHAT IS A COOKIE?

A Cookie is a file that is downloaded to your computer when you access certain web pages. Cookies allow a web page to store and retrieve information about your browsing habits or those of your device, and depending on the information they contain and how you use your device, they can be used to recognize you.

Cookies play a fundamental role in the functioning of the Internet, as they provide technical solutions that allow users to explore different websites. It is important to note that Cookies do not cause any harm to the computer or device on which they are installed. Additionally, they are used to identify and resolve possible malfunctions on a website. They also have applications in advertising and analysis, among other uses.

4. ¿WHAT TYPE OF COOKIES DO WE USE ON OUR WEBSITE?

From **HANTY** we use both own Cookies generated directly by our web domain, and third-party Cookies generated from other websites outside **HANTY**, belonging to third-party companies, and all this for the specific purposes set out below:

(i) Technical Cookies

Technical Cookies are necessary to enable navigation and activate the functionalities of our Website. For example, these Cookies perform vital functions such as controlling traffic and data communication, identifying the User's session, allowing access to restricted areas, ensuring the security of the service against fraud, among others. We do not require your consent to install these Cookies on your device. However, please note that if you disable or block all Cookies in your browser, your browsing experience may not be optimal, and some services may not function correctly.

(ii) Personalization cookies

Personalization Cookies allow us to save information to provide you with a service with special features that can enhance your experience compared to other users. For example, these Cookies can remember how many results you want to see in a search or adjust the appearance and content of the service based on the browser you are using or the region from which you access the service. If you select these personalized features, the Cookies will be considered a service that you have specifically requested, therefore, they will be used exclusively for the selected purpose without the need to request your express consent.

(iii) Analytical Cookies

Analytical Cookies collect information about your visit to our Website to obtain statistics and reports that allow us to improve our performance and collect relevant information without identifying you personally, keeping the information aggregated and anonymous. For example, these Cookies can detect the pages you visit most frequently, as well as find out if you experience error messages on the pages, or the sections of the page you access, or the buttons you click, among others. These Cookies will only be installed on your device if you expressly accept their use.

In these cases, we assure you that necessary measures will be taken to safeguard the privacy, integrity, and availability of such data. If you wish to obtain more information about the international transfers made by each external provider, you can consult their privacy policies in the corresponding section mentioned in this section.

5. ¿HOW TO SET COOKIES?

You can accept or reject Cookies at any time by accessing again our preferences panel that appears when you first access the Website. You will also have the option to access it here:



You can also block or delete Cookies through the browser's configuration tools, or you can configure your browser to warn you when a server wants to store Cookies:

- (i) If you use Microsoft Internet Explorer, you will find the option in the Tools menu > Internet Options > Privacy > Settings.
- (ii) If you use Firefox, you will find the option in the Tools menu > Options > Privacy > Cookies.
- (iii) If you use Chrome, in the Options section > Advanced options > Privacy.
- (iv) If you use Opera, you can configure the browser in the Security and Privacy option.
- (v) If you use Safari, you will find the option in the Preferences/Privacy menu.

6. OTHERS

It should be noted that **HANTY** reserves the right to revise its Cookie Policy at any time it deems appropriate, in which case it will be communicated to the Users. For this reason, we kindly ask you to regularly check this Cookie Policy to have full knowledge of them and to accept, when appropriate, the

relevant Cookies. By accessing and using our Website, as a User, you declare that you have been informed of the conditions regarding the use of our Cookies, without prejudice to the fact that the installation of certain Cookies may require your express consent through the mentioned Cookie settings panel.

This Cookie Policy is complemented by the <u>Privacy Policy</u>, the <u>Terms of Use</u> and the <u>Legal Notice</u>. All of this is without prejudice to any other regulation or legal text that may need to be added, supplemented, or taken into account in compliance with the provisions of the current legislation at any given time.
