Jack "Computer" Cassius started his time within the Foundation soon after being drafted, spurred by the Mississippi Cleanup event. He proved his worth time after time, leading to a rapid rise through the ranks within the 65th General Security Department. Plateauing at the rank of Captain, he reflected on the years dedicated to the department and decided to transfer to Nu-7 'Hammer Down' where he started making a name for himself.

Actions during "War on Pinewood" and the "Canadian Military" infobreaches led to rapid advancement within the Mobile Task Force. Due to the weight he pulled during these operations he was entrusted to work closer with the Ethics Committee and Site Administration in the event now referred to as "Light Step" wherein an anomalous entity happened upon the facility. This entity was left uncontained and thus unidentified due to massive casualties and fatalities. The entity "1" requested assistance from various Mobile Task Forces on site to contain a second entity "2" referred to as it's brother.

their commands. Alongside this was the direction that if they were to hear any form of music they were to hide and make no sound as to remain undetected by what would be assumed as a hostile force.
