EXECUTIVE ORDER N° 26

Establishing the Fremont Office of Glacial Preservation

March 5th, 2023

IN PLAIN ENGLISH

(This section does not constitute a part of the Order)

This order establishes the Fremont Office of Glacial Preservation, as a child agency of the Fremont Environmental Protection Agency, for the purpose of preserving the glaciers of Fremont.

To the People of Fremont, Greeting:

WHEREAS, various cold environments across the globe, including those within the Republic of Fremont's borders, are experiencing a rate of glacier melting at a faster rate than is safe,

WHEREAS, the aforementioned melting of glaciers will result in the rise of sea levels globally and the loss of habitat for several endangered species if left unmitigated,

WHEREAS, it is crucial to this government's environmentally-conscious objectives for the future of Fremont that the glaciers within its borders be effectively preserved and protected.

NOW, THEREFORE, I, MICHAEL D. GRANT, Governor of the Republic of Fremont and in accordance with the authority vested in me by the Constitution and statutes of Fremont, do hereby order as follows:

Sec. 1. Establishing the Fremont Office of Glacial Preservation.

- (a) The Fremont Office of Glacial Preservation is hereby established as a child agency of the Fremont Environmental Protection Agency, for the purpose of conserving and protecting the glaciers of Fremont and any immediately surrounding cold environments.
- (b) The Fremont Office of Glacial Preservation shall be headed by the Fremont Director of Glacial Preservation, who shall submit to the authority of the Secretary for Environmental Protection.
- (c) No person shall be appointed as Director of Glacial Preservation who is not both a citizen of the United States and a resident of the Republic of Fremont for no less than 5 consecutive years. The Director of Glacial Preservation shall be appointed by the Secretary for Environmental Protection.
- (d) The Governor may, at any point, remove the Director of Glacial Preservation from office if they do not consider them to be effectively carrying out their duties.
- (e) The Director of Glacial Preservation may, but is not required to, appoint a Deputy Director of Glacial Preservation to assist them in their role. This individual need not be approved by the Secretary for Environmental Protection or the Governor prior to their appointment.
- (f) The Fremont Office of Glacial Preservation shall have the authority to examine any glacier or related cold environment on state-owned land at any time.

Sec. 2. Glacial Preservation Orders.

- (a) Fremont Office of Glacial Preservation shall, at any time, have the authority to issue a 'Glacial Preservation Order'. These orders will be a document which issues a unique protected status over a glacier on state land. These orders may not be issued to any glacier-like or cold environment that is privately owned. The area to which this order applies must be outlined in the order.

- (b) If any area is issued a Glacial Preservation Order by the Fremont Office of Glacial Preservation, that area will be under the authority of the Fremont Office of Glacial Preservation for as long as the order is in effect. During this time, the Fremont Office of Glacial Preservation is free to enact any conservation measures or install any necessary scientific facilities required to facilitate the protection of the glacier.
- (c) Glacial Preservation Orders shall remain in effect for no more than 5 years, after which they shall expire but may be renewed an infinite number of times by the Office of Glacial Preservation.
- (d) A Glacial Preservation Order may be repealed before it expires by the Director of Glacial Preservation or the Secretary of Environmental Protection or the Governor of Fremont.

Sec. 3. Effect.

- (a) This order shall take effect 25 days after being signed by the Governor of Fremont. The Secretary of Environmental Protection and the Environmental Protection Agency are ordered to use this time to prepare and facilitate the establishment of the Fremont Office of Glacial Preservation.
- (b) Any portion of this order is severable. If any clause or section of this order is repealed or found unconstitutional, the rest shall remain in effect unless also found unconstitutional or repealed by the Governor of the Republic of Fremont.
