Hot Takes:

Summary: An icebreaker activity

- 1. Various debatable topics are picked at random.
- 2. People must introduce themselves; name & major, then read topic to club attendees, after, state personal stance/opinion.
- 3. Attendees must raise their hands and be picked by Reader to respond.

<u>Added Notes</u>: Timer for each topic - 5 minutes max. However, every 5 minutes, vote to keep the topic for a 2 minute extension, if interesting.

Debating Formats:

<u>Opening</u>: 5-10 minutes dedicated at every session no matter the format. Welcome participants, introduce the topic, and explain the goals and guidelines. This will happen at the beginning of

every session, no matter the following format.

**Lincoln-Douglas (Modified for CCM):

Lincoln-Douglas Debate Format

What It's About

- Focus: Debates on values and ethical issues.
- Style: One-on-one discussion where you argue about principles and morals.
- 2. **Debate Flow

Opening Statements:

- Affirmative Opening (6-7 minutes):
 - Make the case for the resolution.
 - Defines key terms, presents their main arguments, and sets up their value framework.
- Negative Opening (6-7 minutes):
 - Challenges the resolution.
- Offers counter definitions and presents their own arguments against the affirmative case.

Rebuttals:

- First Affirmative Rebuttal (4 minutes):
 - Responds to the negative's arguments.

- Strengthens their own case and counters the negative's points.

- First Negative Rebuttal (4 minutes):

- Responds to the affirmative's rebuttal.
- Emphasizes weaknesses in the affirmative case and bolsters their own arguments.

Second Rebuttals:

- Second Affirmative Rebuttal (4 minutes):

- Continues to address any remaining issues.
- Summarizes why their side is stronger.

- Second Negative Rebuttal (4 minutes):

- Wraps up their arguments.
- Highlights why the negative side has the better case.

Crossfire (3 minutes each):

- Crossfire: Both debaters take turns asking each other questions.
 - A chance to clarify arguments and test each other's positions.

5. Closing Speeches:

- Affirmative Summary (3 minutes):
 - Recaps their main points.
 - Shows why their side is the winning one.
- Negative Summary (3 minutes):
 - Reviews the key arguments against the resolution.

- Emphasizes the strengths of the negative position.

6. Final Focus:

- Affirmative Final Focus (2 minutes):
 - Makes a final pitch for their side.
 - Addresses any last points and reinforces why their argument is stronger.
- Negative Final Focus (2 minutes):
 - Final summary of their case.
 - Highlights why the negative position prevails.

3. Other Tips

- **Prep Time**: Each side gets some time during the debate to organize their thoughts.
- **Judging**: Judges look at how clearly you argue your points, how well you use evidence, how effectively you counter your opponent, and overall persuasiveness.

Shortened structure:

- 1. First affirmative constructive (1AC): 5 min
- 2. Cross examination by 2N: 2 min
- 3. First negative constructive (1N): 5 min
- 4. Cross examination by 1A: 2 min
- 5. Second affirmative constructive (2A): 5 min
- 6. Cross examination by 1N: 2 min

-Pause-

- 7. Second negative constructive (2N): 5 min
- 8. Cross examination (2A): 2 min
- 9. Rebuttal prep: 2 min

- 10. Negative rebuttal: 3 min (delivered by either negative)
- 11. Affirmative rebuttal: 3 min (delivered by either affirmative)

Discussion Formats:

Socratic Seminar: In a Socratic Seminar, the discussion will be much more free-form compared to a formal Lincoln Douglas style session. The focus will be on exploring the underlying concepts of the topic through open-ended dialogue. For instance, if we are discussing free will, we will delve into various perspectives: What would determinists argue? How would libertarians respond? What stance would compatibilists take?

Participants are encouraged to actively listen, engage respectfully, and share their personal experiences related to the concept. The facilitator will guide the conversation, ensuring that all voices are heard and that the discussion remains on track. This type of session aims not only to inform participants about philosophical concepts but also to foster a space for open and inclusive discourse.
