IPM Statement

It is the goal of Santa Clara Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to:

- Focus on long-term pest prevention through approved IPM best practices
- Reduce the amount of pesticides used on school campuses

Pest Identification, Monitoring and Inspection

Pest Identification is done by: Robert Burkhart, IPM Technician/Coordinator

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Groundskeeper Specialist- IPM Technician and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

- Visual inspection for pests in common locations
- Communication with school site staff about recent activity
- Set monitoring stations and inspect weekly
- Quarterly school site inspections for pest prevention
