TERMS OF SERVICE

Effective Date: April 1, 2018

The terms of this agreement ("Terms of Service") govern the relationship between you and "Denmukhametov Enver", a Russian individual entrepreneur, legal address: 194354, Russia, Saint-Petersburg, Esenina street, 12/1 regarding your use of Enver Denmukhametov games, websites and related services (the "Service"). Use of the Service is also governed by Enver Denmukhametov Privacy Policy and other relevant policies, which are incorporated herein by reference.

Before accessing or using the Service, including browsing any Denmukhametov Enver website or accessing a game, you must agree to these Terms of Service and the Privacy Policy. You may also be required to register an account on the Service (an "Account"). By registering for an Account or otherwise using the Service, you represent that you are age 13 or older. If you are between the ages of 13 and 17, you represent that your legal guardian has reviewed and agreed to these Terms. If you access the Service from a Social Networking Site ("SNS"), such as Facebook, VK or Google+, you shall comply with its terms of service/use as well as these Terms of Service.

BY INSTALLING, USING OR OTHERWISE ACCESSING THE SERVICE, YOU AGREE TO THESE TERMS OF SERVICE. IF YOU DO NOT AGREE TO THESE TERMS OF SERVICE, PLEASE DO NOT INSTALL, USE OR OTHERWISE ACCESS THE SERVICE. USE OF THE SERVICE IS VOID WHERE PROHIBITED.

Denmukhametov Enver reserves the right, at its discretion, to change, modify, add or remove portions of these Terms of Service, its Privacy Policy and other relevant Denmukhametov Enver policies at any time by posting the amended terms on the Denmukhametov Enver Service. You will be deemed to have accepted such changes by continuing to use the Service. 1. License

1.1. Grant of a Limited License to Use the Service

Subject to your agreement and continuing compliance with these Terms of Service and any other relevant Denmukhametov Enver policies, Denmukhametov

Enver grants you a non-exclusive, non-transferable, non-sub licensable, revocable and limited license to access and use the Service for your own non-commercial entertainment purposes. You agree not to use the Service for any other purpose.

If you are a resident of the United States, these Terms of Service and any dispute arising out of or related to it or Privacy Policy or the Service shall be governed in all respects by California law, without regard to conflict of law provisions. You agree that any claim or dispute you may have against Denmukhametov Enver must be resolved exclusively by a court located in San Francisco, California. If you are a resident outside of the United States, you agree that all disputes between you and Denmukhametov Enver shall be governed by the laws of Russia, without regard to conflict of law provisions. You agree that any claim or dispute you may have against Denmukhametov Enver must be resolved exclusively by a court located in Orenburg, Russia.

9. Severability

You and Denmukhametov Enver agree that if any portion of these Terms of Service or of the Denmukhametov Enver Privacy Policy is found illegal or unenforceable, in whole or in part by any court of competent jurisdiction, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the terms, which shall continue to be in full force and effect.

10. General Provisions

10.1. Assignment

Any notices that you provide without compliance with this Section on Notices shall have no legal effect.

10.6. Equitable Remedies

You acknowledge that the rights granted and obligations made under these Terms of Service to Denmukhametov Enver are of a unique and irreplaceable nature, the loss of which shall irreparably harm Denmukhametov Enver and which cannot be replaced by monetary damages alone so that Denmukhametov Enver shall be entitled to injunctive or other equitable relief (without the obligations of posting any bond or surety or proof of damages) in the event of any breach or anticipatory breach by you.

You irrevocably waive all rights to seek injunctive or other equitable relief, or to enjoin or restrain the operation of the Service or any Denmukhametov Enver game, exploitation of any advertising or other materials issued in connection therewith, or exploitation of the Service or any content or other material used or displayed through the Service and agree to limit your claims to claims for monetary damages, limited by Section 7 (if any).
