Your goals in sending this letter are the following:

- 1. Inform your MP that the government has still not given a sign that it will accede to our demands and that the March 31 deadline is approaching quickly;
- 2. Ask your MP to write to the Minister of Finance to inform them of the impact of the cuts of CAPF to their district.

This letter should be sent by email to your MP's district office (<u>find its contact details here</u>). Follow-up by phone the week after your email is sent.

Our approach and those led by the associations united within the #FutureOfLIVE coalition mobilized the sector, captured the attention of the media, and raised awareness among many politicians. More than 70 MPs from all parties were contacted and more than a third formally indicated their support.

Despite this mobilization, we are still waiting for a signal from the government about the future of the financing of the Canada Arts Presentation Fund. Unless there is a last minute announcement in the Economic Statement or in the 2024 budget, this program will see its budget decreased by \$8 million March 31, 2024.
