

#### **Balancing Literacy Screeners and EL Assessments**

Joint Session with Balanced Assessment Systems (BAS)

#### Tim Odegard, Middle Tennessee State University

This session will explore the critical distinctions between early literacy screeners, diagnostic assessments, and summative English language arts (ELA) assessments. Participants will gain insights into how constructs differ across these assessment types and how these differences influence design, administration and reporting.

Key discussion points include:

- Defining the construct measured by each assessment type.
- Evaluating evidence to ensure assessments function as intended, using summative technical reporting as a reference.
- Understanding the relationship between literacy

screeners and standards-based exams.
