TERMS OF USE

"My", "I", refer to ironicsoap. "Product", "Avatar", and "Content" refer to anything I have listed up on Gumroad, Ko-Fi, or Jinxxy, for sale/download.

When purchasing my products, you are purchasing a license for a **single person** / **accountholder** to use. This license is **non-transferable** except through an agreement with me

If you wish to purchase the product for another person to use, use the Gumroad gifting feature (or any comparable feature on other platforms) to purchase the license for **their email** instead of **your own email**.

In the case of Jinxxy, there is no gifting feature. The other person must make the purchase for their own account.

If you have accidentally double-purchased, contact me and I'll refund the 2nd purchase!

DO NOT:

- Re-sell or re-distribute my avatars, products, or any of the downloaded content I provide
 - INCLUDES, BUT NOT LIMITED TO:
 - Reuploading to another site for free or for sale
 - Sending the files to another person who does not own a license for the product
 - Porting the avatar/product to other software / games with the purpose of reselling or redistributing the port to others who haven't purchased the avatar.
 - Including parts of my product(s) in another product for use by people who do not own a license for the product(s)
 - Uploading onto the accounts of those who do not own the product
- Remove or alter the credit within the chest if the base includes one. This includes modifying the texture.
- Use or edit the avatar in any offensive / hateful ways; such as but not limited to: homophobia, transphobia, racism, antisemitism, hate speech, etc
- Create explicit sexual or fetish edits or use for explicit sexual or fetish content.
- Use for any NFT, crypto, or Al dataset training purposes
- Claim credit for the base
- Please don't upload the included premades to avatar worlds/pedestals, since they have demo versions by me already:)

YOU MAY:

- Use as a streaming avatar (I am not providing a .vrm/.vsf, but conversions are allowed!)
- Use in Youtube / Twitter / TikTok / etc posts!
- Upload as a public avatar on VRChat
 - Public uploads are required to keep the credit toggle within the menu in addition to the credit within the chest. It must be legible and unedited.
- Tag me in your posts!! I'd love to see people using and enjoying the base :]
- Remove the credit button in the menu if the avatar is uploaded as Private (NOT THE CREDIT IN THE CHEST)
- Port the avatar to other software / games, as long as you follow the rest of the TOS:)
 - Uploading the avatar to another software/game where people who have not purchased it may obtain it counts as re-distributing the avatar.

Refunds

- Since I sell digital products, they are impossible to "return". I have no ability of telling if
 you have downloaded the files. As such, I do not offer refunds **outside of Jinxxy**. If you
 have any issues with the base though, please contact me and I'll do my absolute best to
 help:)
- If you've accidentally overpaid for a 2D base while meaning to buy the regular base (need to have paid at least 5\$ over the corresponding 3D base) feel free to reach out to me by email (ironicsoapanimation@gmail.com) and I can either partially refund you the difference, or give you a coupon code for the difference with no expiry date!
 If you've paid the exact price of the 3D base, I will give you a coupon for however much off makes the 3D base = 5\$:)

Commissions

 Selling edit / texturing commissions is allowed! However, both parties need to own the product. Even if the avatar is uploaded as public for the client to clone.

- If you are commissioning someone, you need to ask for their RECEIPT of ownership, do not take their word that they own the base.
 You may be banned from my community and/or have your license revolutions.
 - You may be banned from my community and/or have your license revoked if you are redistributing my products to those who do not own them.
 - If you want to be 100% certain they own the product, have them verify their license key in my discord server. https://discord.gg/RpU6bEFrvy
 - You can also email me at ironicsoapanimation@gmail.com with a license key and I can manually verify that it is valid:)
- Selling assets for my bases is allowed! You cannot include any of the base's original content and must state that the avatar is not included in the asset package.
 - Using my logos or branding(visual) to advertise with is not allowed. (SoapCats, SoapDogs, Sealines, etc..)
 - Absolutely no NSFW / Fetish assets.
 - An "Asset" is a wholly original model or file that you have created that is intended to be
 used in conjunction with one(or more) of my bases. If it contains any part of the original
 files created by me, you need to contact me about selling it first. I'll need to make sure
 you're properly verifying people own the base before getting access to your edit
- Other commercial use situations that are not covered here, PLEASE contact me about!
 (3D printing, using in merch, etc)

What happens if you break my TOS?

- You will be banned from all community spaces I moderate (Discord and VRC Group)
- Your license to my content will be revoked if the violation is severe enough
