Account Information

User Content

• Barks (posts and other content you share within the app)

Usage Data

We may collect non-personal information about how you interact with the app, such as:

- Device type and operating system
- App usage statistics

• Interaction data (likes, views, etc.)

How We Use Your Information

We use the information we collect to:

- Create and manage your account
- Display your profile and Barks to other users
- Improve and personalize the user experience
- Maintain app security and prevent misuse
- Communicate with you about updates or important notices

Sharing of Information

We do **not** sell your personal information. Your public profile and Barks may be visible to other users within the app. We may share limited data with service providers who help us operate Wuphp (such as hosting or analytics providers), but only as necessary to provide the service and under strict confidentiality agreements.

We may also disclose information if required by law or to protect the safety and rights of our users or platform.

Data Security

We take reasonable precautions to protect your personal information. Passwords are encrypted, and we implement technical measures to prevent unauthorized access. However, no method of transmission or storage is 100% secure, and we cannot guarantee absolute security.

Your Rights

Depending on your location and applicable law, you may have the right to:

- Access the personal information we hold about you
- Request corrections to your information
- Request deletion of your account and data
